10	WHEREAS, the completion of the Louisiana State University Women's Center
11	expansion will allow for additional programs, services, and collaborations to address issues
12	impacting women on LSU's campus, in the capital area community, and throughout
13	Louisiana; and
14	WHEREAS, the Louisiana State University Women's Center will celebrate the
15	completion of the expansion project with a ribbon cutting ceremony on May 2, 2013.
