5	WHEREAS, Ray Castle, an athletic trainer, associate professor, and program
6	director for LSU's Bachelor of Science program in Athletic Training, attended the Boston
7	Marathon with three athletic training students from LSU: Derek Carter, Brendan Jacob, and
8	graduating senior, Caitlyn McKinley; and
9	WHEREAS, the group volunteered to serve as part of a comprehensive medical
10	team of over one hundred thirty athletic trainers and athletic training students responsible
11	for the health and safety needs of the nearly seventeen thousand race entrants serving as first
12	responders at the finish line and in medical tents; and
13	WHEREAS, Ray and his students were stationed near the finish line, approximately
14	fifty meters away from the blast site, and were among the first of the medical personnel to
15	reach the injured runners and bystanders and provided emergency medical assistance; and
16	WHEREAS, their efforts and quick response, along with that of so many other health
17	care providers that day, served to assist over two hundred victims of the disaster and to save
18	lives; and

1	WHEREAS, through their response and efforts, the group serves as role models and
2	a credit to the LSU community, the state of Louisiana and to the athletic training profession
3	as a whole.
4	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
5	commend and recognize Ray Castle, Derek Carter, Brendan Jacob, and Caitlyn McKinley
6	for providing volunteer emergency medical assistance to the victims of the recent Boston
7	Marathon bombing.
