Amendments proposed by Representative Johnson in the Committee of the Whole House to Engrossed House Bill No. 1 by Representative Fannin

1 AMENDMENT NO. 1

2 On page 95, between lines 29 and 30, insert the following:

3 "Provided, however, that none of the monies appropriated herein may be paid to any hospital
 4 pursuant to a public-private partnership with the state or any higher education management
 5 board unless and until such partnership has been approved by each house of the legislature.
 6 The commissioner of administration is hereby authorized and directed to transfer the amount
 7 necessary to the Louisiana State University Health Science Center Health Care Services
 8 Division for operation of any hospitals for which a public-private partnership is not
 9 effectuated."

10 AMENDMENT NO. 2

11 On page 202, after line 46, add the following:

12 "Provided, however, that the appropriations contained herein for the remainder of this
 13 Schedule shall be effective until the public-private partnerships with the state or any higher
 14 education management board of the state are approved by the legislature:

1 collaboration with the U.S. Department of Veterans Affairs on the building of a hospital
2 complex in New Orleans and on the operations at the Medical Center of Louisiana at New
3 Orleans, including the capacity and cost for the expansion of services at this facility to 350
4 beds during the fiscal year.

5 Notwithstanding any provision to the contrary, the Louisiana State University Health Care
6 Services Division is authorized to transfer authorized positions between programs within the
7 Louisiana State University Health Care Services Division budget unit, subject to the
8 approval of the Board of Supervisors of Louisiana State University and Agricultural and
9 Mechanical College and notification to the commissioner of administration and the Joint
10 Legislative Committee on the Budget within 30 days. Such transfers shall be made to
11 provide for the effective delivery of services by the Louisiana State University Health Care
12 Services Division."
