SENATE RESOLUTION NO. 96

BY SENATOR MORRISH

AGRICULTURAL COMMODITIES. Requests the commissioner of agriculture to create the Louisiana Wine Agribusiness Task Force within the Department of Agriculture and Forestry.

A RESOLUTION

2	To urge and request the commissioner of agriculture to create the Louisiana Wine
3	Agribusiness Task Force within the Department of Agriculture and Forestry to study
4	and make recommendations to the legislature for growing and expanding the wine
5	industry with respect to economic impact, job growth, revenue generation, and
6	tourism potential.
7	WHEREAS, Louisiana wine agribusiness means the cultivation, harvest, production,
8	distribution, transportation, sale and consumption of native grown grapes and produced
9	wine; and
10	WHEREAS, the wine agribusiness should promote and foster the growth of
11	Louisiana agricultural business; and
12	WHEREAS, surrounding states have nurtured a thriving wine agribusiness industry
13	from Virginia to Texas, generating hundreds of millions of dollars for their state's general
14	fund; and
15	WHEREAS, these same states are gainfully employing tens of thousands in full-time
16	jobs directly and indirectly related to the wine growing industry.
17	THEREFORE, BE IT RESOLVED that the Louisiana Senate does hereby urge and
18	request the commissioner of agriculture to create the Louisiana Wine Agribusiness Task

1	Force within the Department of Agriculture and Forestry to study and make
2	recommendations to the legislature for growing and expanding the wine industry with
3	respect to economic impact, job growth, revenue generation, and tourism potential.
4	BE IT FURTHER RESOLVED that the Louisiana Wine Agribusiness Task Force
5	shall at a minimum include the following members or their designees:
6	(1) The speaker of the House of Representatives.
7	(2) The president of the Senate.
8	(3) The commissioner of agriculture and forestry.
9	(4) The secretary of Louisiana Economic Development.
10	(5) The secretary of the Louisiana Department of Revenue.
11	(6) The chairman of the Senate Committee on Agriculture, Forestry, Aquaculture,
12	and Rural Development.
13	(7) The chairman of the House Committee on Agriculture, Forestry, Aquaculture,
14	and Rural Development.
15	(8) The chairman of the Senate Committee on Commerce, Consumer Protection, and
16	International Affairs.
17	(9) The chairman of the House Committee on Commerce.
18	(10) A representative from the LSU AgCenter extension offices.
19	(11) A representative from the Louisiana National Federation of Independent
20	Business.
21	(12) A representative from the Louisiana Wine Growers Association.
22	(13) A representative from the Louisiana Farm Bureau.
23	(14) The commissioner of the Louisiana Office of Alcohol and Tobacco Control.
24	BE IT FURTHER RESOLVED that the task force shall convene no later than
25	September 1, 2013, and at the first meeting the task force shall elect a chair, who shall be
26	responsible for calling all subsequent meetings, and shall also elect such other officers as it
27	deems appropriate. The majority of the membership shall constitute a quorum and any
28	official action of the task force shall require a vote of the majority of the quorum presenting
29	and voting.

BE IT FURTHER RESOLVED that the members of the task force shall serve

without compensation, except any per diem or expense reimbursement to which they may be individually entitled as members of their respective organizations.

BE IT FURTHER RESOLVED that the task force shall report its findings, together with any recommendations for action, to the House and Senate agriculture committees and House and Senate commerce committees no later than March 1, 2014, and shall thereafter report annually to the legislature not later than March 1.
