15	Louisiana, the United States Court of Appeals, Fifth Circuit, and the United States Supreme
16	Court; and
17	WHEREAS, Mrs. Dick was recommended for the position on the federal bench by
18	Senator Mary Landrieu, nominated by President Barack Obama, and was confirmed by the
19	United States Senate on May 9, 2013, as the first female United States District Judge for the
20	Middle District of Louisiana; and
