COMMENDATIONS: Commends former legislator Clif Richardson for his service to Central, East Baton Rouge Parish, and the House of Representatives

1 A RESOLUTION

2 To commend former state representative Clifton "Clif" Richardson for his service and many  
3 contributions to Central, East Baton Rouge Parish, and the Louisiana House of  
4 Representatives.

5 WHEREAS, former state representative Clif Richardson resigned his seat in the  
6 House of Representatives early in 2013, and it is appropriate to commend him for his many  
7 years of dedicated service; and

8 WHEREAS, Mr. Richardson is a Vietnam War veteran, Quartermaster 2nd Class,  
9 United States Navy, and has spent the majority of his career as an electrician in the Central  
10 area; and

11 WHEREAS, Mr. Richardson is married to the former Sylvia Dianne Carpenter, and  
12 they are the proud parents of two children, Mark and Robin Stewart; and

13 WHEREAS, during his tenure in the House of Representatives, Mr. Richardson  
14 served on the civil law, education, and municipal, parochial and cultural affairs committees;  
15 and

16 WHEREAS, since 1968, Mr. Richardson has been the owner and manager of Rebel  
17 Electric LLC, and he served as a Justice of the Peace from 1991 to 2007; and

18 WHEREAS, Mr. Richardson is a member of several civic and business associations,  
19 including Cooking for Our Neighbors and Kids Campaigns, City-Parish Electrical Board,  
20 Central Chamber of Commerce, Central Area Business Association, and the Central  
21 Volunteer Fire Department; and

1           WHEREAS, Mr. Richardson has also served as a deacon and chairman of the  
2 Stewardship Committee at Fellowship Baptist Church, as a coach of the Central Area Youth  
3 League baseball and the Christian Elementary Football League teams, and as chairman of  
4 the American Subcontractors Association; and

5           WHEREAS, Mr. Richardson merits a sincere measure of commendation for his  
6 service to the Central community, East Baton Rouge Parish, and to the Louisiana House of  
7 Representatives.

8           THEREFORE, BE IT RESOLVED that the House of Representatives of the  
9 Legislature of Louisiana does hereby commend Clif Richardson for his many years of highly  
10 effective service as a member of the House of Representatives, does hereby record for  
11 posterity his contributions to East Baton Rouge Parish and the community of Central, and  
12 does hereby extend to him best wishes for health and happiness in the future.

13           BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted  
14 to former state representative Clif Richardson.
