
HOUSE COMMITTEE AMENDMENTS

Amendments proposed by House Committee on Ways and Means to Original House Bill No. 688 by Representative Johnson

1 AMENDMENT NO. 1

2 On page 1, line 15, after "disaster." and before "The" insert the following:

3 "To be eligible for the tax credit, qualified expenses and investments shall be those
4 that are certified by the Department of Revenue as eligible. The total aggregate
5 amount of tax credits which may be issued for all taxpayers for purposes of this
6 Section shall not exceed one million dollars in any tax year."

7 AMENDMENT NO. 2

8 On page 2, at the beginning of line 3, after "B." insert the following:

9 "(1) To be eligible for the tax credit, a business shall first receive pre-
10 clearance of its emergency preparedness plan from the Office of Emergency
11 Preparedness and Homeland Security, hereinafter referred to as "office". An
12 emergency plan shall include the estimated amount of qualified expenses and
13 investments which the business intends to claim for purposes of the tax credit, as
14 well as any documents or other materials required by the office relative to the pre-
15 clearance process. The office shall by rule establish requirements for application for
16 and approval of pre-clearance status. Each tax year, the authority for the office to
17 grant pre-clearance status to emergency preparedness plans shall be limited to that
18 number of plans containing estimated qualified expenses and investments which, in
19 the aggregate, would generate no more than one million dollars in tax credits.

20 (2) To claim a tax credit, in addition to any other documentation the
21 Department of Revenue may require, a business shall also submit to the department
22 evidence of the pre-clearance status of its emergency preparedness plan.

24 AMENDMENT NO. 3

25 On page 2, line 12, after "hospitals," and before "network" delete "and" and at the end of the
26 line after "stations" and before the period "." insert a comma "," and insert the following:

27 "restaurants, and trucking businesses which transport essential commodities to gas
28 stations, pharmacies, grocery stores, and hospitals."

29 AMENDMENT NO. 4

30 On page 2, at the beginning of line 20, delete "C." and insert "D."

31 AMENDMENT NO. 5

32 On page 2, line 25, after "situation." delete the remainder of the line, and delete lines 26 and
33 27 in their entirety.

34 AMENDMENT NO. 6

35 On page 2, at the beginning of line 28, delete "D." and insert "E."

1 AMENDMENT NO. 7

2 On page 3, between lines 4 and 5, insert the following:

3 "F. The Department of Revenue and the Office of Emergency Preparedness
4 and Homeland Security shall promulgate rules and regulations in accordance with
5 the Administrative Procedure Act for purposes of implementation and administration
6 of the tax credit program authorized by this Section.

7 Section 2. The provisions of this Act shall apply to income tax years
8 beginning on and after January 1, 2014, and to corporation franchise tax years
9 beginning January 1, 2015."

10 AMENDMENT NO. 8

11 On page 3, at the beginning of line 5, delete "Section 2." and insert "Section 3."
