12	senior Chris Feron shot 85-83 and finished with a 168, senior Tucker Smith shot 85-82 and
13	had a score of 167, and sophomore Zach Pickett shot 92-93 and ended with 185; and
14	WHEREAS, Jacob Davis, Corey Kennedy, Austin Northcott, and Corey Moss also
15	merit a special measure of commendation for their contributions to the winning effort of the
16	Cougars; and
17	WHEREAS, the amazing accomplishments could not have been achieved without
18	the guidance and skill of head coaches Katie Eagles and Gwen Barron, as well as all of the
19	other individuals who contribute to the success of the Cedar Creek golf program; and
20	WHEREAS, the Cougar golf team has won five consecutive state titles from 2009-
