COMMENDATIONS: Commends Mr. Willie F. Hawkins upon his retirement from the LSU System

A CONCURRENT RESOLUTION

2	To commend Mr. Willie F. Hawkins for his forty-two years of distinguished service to the
3	citizens of Louisiana and Baton Rouge in the areas of higher education, health care,
4	and social services.
5	WHEREAS, since 1984, Mr. Hawkins has served in several high level state health
6	care administrative positions, including sixteen years with the Louisiana State University
7	(LSU) System; and
8	WHEREAS, in 1978, Mr. Hawkins began his public service when he was named the
9	executive director of the Eden Park Community Health Center, and also served as the
10	administrator of East Baton Rouge Parish Health Care Services; and
11	WHEREAS, early in his professional career, Mr. Hawkins served in several not-for-
12	profit positions in the Baton Rouge community including director of Health and Social
13	Services for Community Advancements, Inc., and director of the Young Adult Offender
14	Program for the Community Corrections and Rehabilitation Center; and
15	WHEREAS, Mr. Hawkins was the recipient of the prestigious Ford Foundation
16	Fellowship Award in 1974; and
17	WHEREAS, Mr. Hawkins was named executive assistant to the vice chancellor at
18	the LSU Health Sciences Center New Orleans-Health Care Services Division and chief
19	executive officer of the Medical Center of Louisiana in New Orleans in July 1999; and
20	WHEREAS, Mr. Hawkins served as the executive assistant to the vice chancellor at
21	LSU Health Sciences Center from July 1997 to July 1999; and

1	WHEREAS, prior to his service with LSU, Mr. Hawkins served as the confidential
2	assistant to the chief executive officer of the Louisiana Health Care Authority from
3	November 1993 to August 1995 and from January 1996 to July 1997; and
4	WHEREAS, under the Louisiana Health Care Authority, Mr. Hawkins served as the
5	acting administrator of Earl K. Long Medical Center from August 1995 to January 1996,
6	and as an assistant administrator from April 1984 to November 1993; and
7	WHEREAS, Mr. Hawkins graduated from Southern University in 1965 with a
8	Bachelor of Science degree in business administration and served as a vista volunteer at the
9	Columbia University School of Social Work from 1966 to 1967; and
10	WHEREAS, Mr. Hawkins is a distinguished veteran of the United States Army
11	having honorably served with the Military Assistance Command in Vietnam; and
12	WHEREAS, Mr. Hawkins retires on July 5, 2013, from LSU as the director of
13	Institutional Relations, a position that he has held since February of 2004; and
14	WHEREAS, Mr. Hawkins can be found on any given day, at any given hour,
15	navigating patients through the often complicated Louisiana health care system; and
16	WHEREAS, Mr. Hawkins not only provided professional administrative leadership
17	in public healthcare for many years, but also personally ensured that thousands of patients
18	were able to receive medical appointments and emergency treatment regardless of their
19	ability to pay; and
20	WHEREAS, there is not a single local official of city or state government, a local
21	minister, a city-parish department head, or a local community leader, that Mr. Hawkins does
22	not know on a first-hand basis; and
23	WHEREAS, Mr. Hawkins provided invaluable legislative assistance on behalf of
24	LSU by keeping "watch" from a key seat on the House floor; and
25	WHEREAS, Mr. Hawkins was extremely instrumental in securing, from the Brown
26	family, the donation of property that make up a strategic part of the new medical clinic and
27	urgent care center campus in North Baton Rouge; and
28	WHEREAS, in 2011, while providing information to a legislator on a piece of
29	legislation vital to LSU, and attempting to simultaneously navigate a steep staircase in the

1 capitol, Mr. Hawkins fell and broke his hip sidelining him but not his telephone dialing

- 5 care of Louisiana's residents.
