6	Louisiana, where he has been a lifelong resident; and
7	WHEREAS, Louisiana Governor Earl K. Long in 1950 appointed Leroy Seal to serve
8	as the first marshal in the village of Varnado, where Mr. Seal served for three years; and
9	WHEREAS, in 1954, Leroy Seal went to work for the Louisiana Department of
10	Wildlife and Fisheries, from which he retired in 1979, having served the people of Louisiana
11	for more than a quarter century, during which time he was selected by his peers as a "Top
12	Woodsman" and promoted to the position of Major, with enforcement responsibility over
13	fifteen parishes; and
14	WHEREAS, Leroy Seal served from 1981 to 1991 as Chief Deputy of the
15	Washington Parish Sheriff's Office under Washington Parish Sheriff Benny Rayburn; and
16	WHEREAS, in 1992, Leroy Seal was elected Chief of Police in the village of
17	Varnado, where he served as chief from 1992 through 2008; and
18	WHEREAS, Chief Seal stepped down as chief in 2008 and continued to serve as a

1	police officer for the village of Varnado from 2008 through 2012; and
2	WHEREAS, Leroy "Slick" Seal will celebrate his ninety-third birthday on September
3	2, 2013; and
4	WHEREAS, Leroy "Slick" Seal has devoted his entire life to protecting the public
5	while serving in the line of duty as a law enforcement official; and
6	WHEREAS, Leroy "Slick" Seal's lifelong public service to the people of Varnado,
