Amendments proposed by Senate Committee on Finance to Reengrossed House Bill No. 629

AMENDMENT NO. 1

In Senate Committee Amendment No. 19 proposed by the Senate Committee on Revenue and Fiscal Affairs and adopted by the Senate on May 22, 2013, on page 3, line 6, after "(2)" delete the remainder of the line and insert the following:

"Each agency shall refer non-final delinquent debts requiring legal action or legal proceedings, other than administrative proceedings within such agency, to the attorney"

AMENDMENT NO. 2

In Senate Committee Amendment No. 19 proposed by the Senate Committee on Revenue and Fiscal Affairs and adopted by the Senate on May 22, 2013, 3, at the end of line 7, insert a comma "," and insert "or other time period as provided"

AMENDMENT NO. 3

In Senate Committee Amendment No. 19 proposed by the Senate Committee on Revenue and Fiscal Affairs and adopted by the Senate on May 22, 2013, on page 3, line 9, after "general and" and before "or" delete "other agencies" and insert "any such agency"

5 AMENDMENT NO. 7

6 On page 3, between lines 4 and 5, insert the following:

17 On page 5, line 4, change "or" to "and"

18 AMENDMENT NO. 9

1 On page 7, delete lines 19 through 22

2 AMENDMENT NO. 10

3 On page 7, line 24, change "of the delinquent debt." to "of debt which has become final after  
4 the initial effective date of this Section."

5 AMENDMENT NO. 11

6 On page 7, line 29, after "Section" delete the remainder of the line and on page 8, delete lines  
7 1 and 2, and insert the following:

8 "shall be transferred to the referring agency within thirty days after the end of the  
9 month in which the monies were collected and shall be used by such agency as they  
10 would have been had they been timely collected. However, any monies collected for  
11 delinquent debt as a result of nonpayment of tax liabilities pursuant to Title 47 of the  
12 Louisiana Revised Statutes of 1950, as amended, after deposit into the state general  
13 fund, the first five million dollars shall be appropriated by the legislature beginning  
14 in Fiscal Year 2013-2014, and for four consecutive fiscal years thereafter, to the  
15 Office of State Police for a training academy class."
