1 AMENDMENT NO. 1

2 On page 1, change "24:513(D)(7)" to "24:603(20)"

4 On page 1, line 6, change "duties" to "functions"

6 On page 1, at the beginning of line 7, change "auditor;" to "fiscal office;"

7 AMENDMENT NO. 4

9 AMENDMENT NO. 5

10 On page 1, delete lines 11 through 16, and insert the following:

11 "§603. Duties and functions
12 Subject to the general direction and supervision of the Joint Legislative
13 Committee on the Budget, the Legislative Fiscal Office shall have the following
14 duties and functions:"

15 AMENDMENT NO. 6

16 On page 2, delete lines 1 through 7 and insert the following:

17 "(20) The Legislative Fiscal Office shall review the proposed executive
18 budget for the ensuing fiscal year and report to the Joint Legislative Committee on
19 the Budget whether the budget recommends appropriations out of the state general
20 fund and dedicated funds for health care as contained in Schedule 09, Department
21 of Health and Hospitals, and for higher education as contained in Schedule 19,
22 Higher Education and Louisiana State University Health Sciences Center Health
23 Care Services Division, in amounts less than the appropriations for either purpose
24 as contained for the same schedules in the existing operating budget for the current
25 fiscal year as of the day the executive budget is submitted to the Joint Legislative
26 Committee on the Budget. Within seven days of the governor's submission of the
27 executive budget to the Joint Legislative Committee on the Budget pursuant to R.S.
28 39:37, the Legislative Fiscal Office shall prepare and submit such report to the
29 governor and the legislature."

30 AMENDMENT NO. 7

31 On page 2, line 27, change, "means" to "includes, but is not limited to,"

32 AMENDMENT NO. 8

33 On page 5, delete lines 9 through 13 and insert the following:

34 "that the Legislative Fiscal Office reports that the budget estimate as provided by
35 Article VII, Section 11(A) of the Constitution of Louisiana provides for

1 appropriations out of the state general fund and dedicated funds for the ensuing fiscal
2 year for health care as contained in Schedule 09, Department of Health and
3 Hospitals, and for higher education as contained in Schedule 19, Higher Education
4 and Louisiana State University Health Sciences Center Health Care Services
5 Division, in amounts less than the appropriations for either purpose as contained for
6 the same schedules in the existing operating budget for the current fiscal year as of
7 the day the executive budget is submitted to the Joint Legislative Committee on the
8 Budget, the governor shall cause a General Appropriation"

9 AMENDMENT NO. 9

10 On page 5, delete lines 17 and 18 and insert "are subject to appropriation."

11 AMENDMENT NO. 10

12 On page 5, line 21, change "seven" to "~~seven~~ fourteen"

13 AMENDMENT NO. 11

14 On page 5, between line 23 and 24, insert the following:

15 "Section 2. The provisions of Section 1 of this Act shall be null, void, and of no
16 effect on June 30, 2015."

18 On page 5, line 24, change "Section 2." to "Section 3."
