2	To commend the students, faculty, and staff of Southern University at New Orleans (SUNO)
3	on the establishment of a westbank campus at the L.B. Landry/O. Perry Walker High
4	School site for the primary benefit of westbank residents.
5	WHEREAS, SUNO is a public, historically black university that creates and
6	maintains an environment conducive to learning and growth, as well as promotes the upward
7	mobility of a diverse population of both traditional and nontraditional students through
8	quality academic programs and service to achieve excellence in higher education; and
9	WHEREAS, leaders in both secondary and postsecondary education have lamented
10	the lack of educational options on New Orleans' west bank; and
11	WHEREAS, starting in August 2013, SUNO faculty will move into the unified L.B.
12	Landry and O. Perry Walker High School building, where they will teach between twelve
13	and fifteen first-year courses in English, biology, math, social work, criminal justice and
14	others; and
15	WHEREAS, the August roll-out will include space for students to register for classes
16	and apply for financial aid; and
17	WHEREAS, the partnership between SUNO and the high school was solidified by
18	the signing of a memorandum of understanding on Tuesday, April 2, 2013; and
19	WHEREAS, the partnership was heralded by O. Perry Walker High School Principal
20	Mary Laurie as "the beginning of a dream realized".
