| 4 | WHEREAS, it is with deep regret and a profound sense of sadness that the citizens |
| 5 | of Louisiana and the Senate of the Legislature of Louisiana have learned of the death of |
| 6 | Robert L. "Buck" Kleinpeter, on May 18, 2013, at the age of eighty-eight; and |
| 7 | WHEREAS, it is only fitting to recognize and record for posterity the unique and |
| 8 | wonderful legacy that is left by Buck Kleinpeter; and |
| 9 | WHEREAS, Buck Kleinpeter was born in Baton Rouge, Louisiana, on September |
| 10 | 28, 1924, the son of George Buffington Kleinpeter and Ethel McDaniel Kleinpeter; and |
| 11 | WHEREAS, his studies at Louisiana State University were interrupted by his service |
| 12 | in World War II, where he served in the Army Air Corps in the Aleutians, India, China and |
| 13 | the South Pacific theaters flying bombing missions as a tail gunner; and |
| 14 | WHEREAS, after he returned home from the war, he finished his undergraduate |
| 15 | studies at Louisiana State University and received his law degree in 1950 from LSU Law |
| 16 | Center, where he was a member of Phi Delta Phi Legal Fraternity and editor of the Law |
| 17 | Review; and |
| 18 | WHEREAS, after graduation from law school, he graduated from the FBI Academy |

| 1 | in Quantico, Virginia, and served as a special agent where he was assigned to the Los |

| 4 | WHEREAS, during this time he married his wife, Rachel Williams Kleinpeter, and |
| 5 | in 1952, they returned to Baton Rouge to raise their children, Melanie Anne Kleinpeter and |
| 6 | Robert Loren Kleinpeter, both of whom also became lawyers and practiced law with their |
| 7 | father; and |
| 8 | WHEREAS, Buck began his private practice of law in Baton Rouge in 1952 and |
| 9 | continued in the active practice of law until 2007; and |
| 10 | WHEREAS, he was actively engaged in the service of the legal field outside of his |
| 11 | trial practice, which was legendary, and he was a fellow of the American College of Trial |
| 12 | Lawyers, a fellow of the International Society of Barristers, a sustaining member of the |
| 13 | American Judicature Society, a longtime member of the International Association of Defense |
| 14 | Counsel, a member of the Defense Research Institute and National Association of Criminal |
| 15 | Defense Attorneys; and |
| 16 | WHEREAS, he served on the Advisory Committee of the Louisiana Law Institute |
| 17 | for the Revision of the Code of Criminal Procedure, and as a member of the Permanent |
| 18 | Committee of the Continuous Revision of the Code of Criminal Procedure, Louisiana Law |
| 19 | Institute; and |
| 20 | WHEREAS, for many years he was an adjunct professor of law at LSU Law School |
| 21 | in the areas of criminal law, criminal procedure and trial practice; and |
| 22 | WHEREAS, he was admitted to practice in all state and federal courts in Louisiana |
| 23 | as well as the U. S. Supreme Court; and |
| 24 | WHEREAS, Buck was deeply involved in the American Legion, where he was a Life |
| 25 | Member of the Nicholson Post No. 38, where he served on the executive and legal |
| 26 | committees for twelve years as well as the Istrouma and Fairfields Lodges; and |
| 27 | WHEREAS, he received his Entered Apprentice, Fellow Craft, and Master Mason |
| 28 | Degrees at Istrouma Lodge No. 414, F. & A.M. 1946 and afterwards was a Charter Member |
| 29 | of Fairfields Lodge No. 425, F. & A.M., where he was a Past Master; and |
| 30 | WHEREAS, he also served the Grand Lodge of the State of Louisiana, F. & A.M. |

as Grand Senior Deacon, Grand Attorney, Grand Junior Warden, Grand Senior Warden,

Deputy Grand Master, and Grand Master as well as numerous other Masonic affiliations; and

WHEREAS, Buck believed deeply in giving back to the community of Baton Rouge that had given him so much, he was a member of Paul Harris fellow of the Baton Rouge Rotary Club, served on the boards of the Girl Scouts of America, Junior Achievement, and the Istrouma Area Council of Boy Scouts of America; and

WHEREAS, Buck Kleinpeter was a loving and dedicated husband to his wife of sixty-two years Rachel Williams Kleinpeter, a cherished father to his daughter Melanie and her husband David and his son Loren and his wife Rachel, and a devoted grandfather to his grandchildren Clayton, Alden, Regan, Peter, Brett, Brandyi, and great-granddaughter, Adler; and

WHEREAS, the Baton Rouge legal community was made a better place for the outstanding trial work and impeccable legal ethics of Buck Kleinpeter and the love that he had for his community, state and country was noticeable in his work, and a tremendous loss will be felt by all that were honored to have known him.

THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana does hereby express sincere and heartfelt condolences upon the death of Robert L.
