3 Orleans area as a special prosecutor and assistant district attorney for the Twenty-Ninth
4 Judicial District Court from 1972 to 1975, as a judge in the Twenty-Ninth Judicial District
5 Court from January 1982 through December 1996, as legal counsel to the Port of South
6 Louisiana from April 2000 to April 2005 and as executive director of the Port of South
7 Louisiana from April 2005 to July 2013; and

8 WHEREAS, Judge Chaisson is married to the former Bobbie Gulledge and they are
9 the proud parents of Joel II, Robert, Walter, Paul, Jared, Maria, John, David, and Eve; and

10 WHEREAS, Judge Chaisson is a member of many professional and civic

12 Judges Association, American Judicature Society, Fourth and Fifth Circuit Judges
13 Association, Twenty-Ninth Judicial District Bar Association, Louisiana State University

22 life, Judge Chaisson merits a sincere measure of commendation for his singular contributions
23 and the exemplary strides he has taken as an exceptional former member of the Louisiana
