AN ACT

2	To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2014-
3	2015 to be used to pay the consent judgment in the suit entitled "David Gibson v.
4	Jack Lawton, Jr., Lawton Ranch, LLC and Travelers Indemnity Company of
5	Connecticut, State of Louisiana, through the Department of Transportation and
6	Development and the Parish of Calcasieu"; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. The sum of Six Thousand Three Hundred Five and 32/100 (\$6,305.32)
9	Dollars is hereby appropriated out of the General Fund of the state of Louisiana for Fiscal
10	Year 2014-2015 to be used to pay the consent judgment in the suit entitled "David Gibson
11	v. Jack Lawton, Jr., Lawton Ranch, LLC and Travelers Indemnity Company of Connecticut,
12	State of Louisiana, through the Department of Transportation and Development and the
13	Parish of Calcasieu", bearing Number 2010-002648 on the docket of the Fourteenth Judicial
14	District Court, parish of Calcasieu, state of Louisiana.
15	Section 2. This Act shall become effective on July 1, 2014; if vetoed by the governor
16	and subsequently approved by the legislature, this Act shall become effective on July 1,
17	2014, or on the day following such approval by the legislature, whichever is later.
