TAX/TAXATION. Removes the authority of the Louisiana Tax Free Shopping Program to charge participating retailers a membership fee. (gov sig)

1	AN ACT
2	To amend and reenact R.S. $51:1304(C)(4)$, $1305(A)$, the introductory paragraph of $1305(B)$,
3	1305(C), and 1309(B), and to repeal R.S. 51:1302(7), relative to the Louisiana Tax
4	Free Shopping Program; to remove the authority of the program to charge
5	participating retailers a membership fee; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 51:1304(C)(4), 1305(A), the introductory paragraph of 1305(B),
8	1305(C), and 1309(B) are hereby amended and reenacted to read as follows:
9	\$1304. Establishment of the program by the commission
10	* * *
11	C. The commission shall have all powers, duties, and authority necessary to
12	implement or take any action under this Chapter, including the following:
13	* * *
14	(4) Shall set membership fees and handling fees as follows:
15	(a) The membership fee shall be set by the commission and may be reviewed
16	periodically by the commission and may then be reasonably adjusted.
17	(b) A handling fee shall \underline{to} be charged to an international traveler for

1	processing each refund, which fee may be deducted from the amount of the refund.
2	The fee may be reviewed periodically by the commission and may then be
3	reasonably adjusted.

5	§1305. Retailer's participation
6	A. Retailers who elect to participate in the tax free shopping program shall
7	register with the refund agency, pay the membership fee, and agree in writing with
8	the refund agency as to the location and the method of operating an international
9	traveler's refund desk for each of their participating stores, including a system of
10	record keeping for refund forms issued from the desk.
11	B. Upon payment of the fee and upon reaching agreement with the agency
12	with regards to the operation of the refund desk for each store, the retailer shall be
13	entitled to participate in the program. He shall receive or be entitled to:
14	* * *
15	C. No retailer who participates in unfair methods of competition and unfair
16	or deceptive acts or trade practices in the conduct of his business, or who is
17	otherwise found to have violated R.S. 51:1405 or any rule or regulation adopted
18	pursuant thereto shall participate in the Tax Free Shopping Program. The refund
19	agency shall take immediate action to exclude such retailer from the program and
20	recover any signs, decals, refund forms, or other indicia of program participation
21	from the retailer. Such retailer shall not be entitled to a refund of any fee or other
22	costs previously paid.

24	§1309. Reimbursement of refund agency

26	B. The refund agency shall establish a budget for the program, taking into
27	account anticipated required appropriations for the program based on handling fees,
28	and taking into account membership fees, other state or local appropriations, any
29	donations, and the expenses of its own compensation.

2	Section 2. R.S. 51:1302(7) is hereby repealed.
3	Section 3. This Act shall become effective upon signature by the governor or, if not
4	signed by the governor, upon expiration of the time for bills to become law without signature
5	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
6	vetoed by the governor and subsequently approved by the legislature, this Act shall become
7	effective on the day following such approval.

<u>Proposed law</u> removes the authority of the Louisiana Tax Free Shopping Program to charge participating retailers a membership fee.

Effective upon signature of the governor or lapse of time for gubernatorial action.

(Amends R.S. 51:1304(C)(4), 1305(A), 1305(B) (intro para), 1305(C), and 1309(B); repeals R.S. 51:1302(7))
