EMPLOYMENT. Constitutional amendment to provide, with certain exemptions, for a state minimum wage effective January 1, 2015. (2/3-CA13s1(A))

1	A JOINT RESOLUTION
2	Proposing to add Article XII, Section 17 of the Constitution of Louisiana, relative to the
3	establishment of a state minimum wage; to provide relative to employers with fifty
4	full-time employees or more; to provide for a minimum hourly wage; to provide
5	relative to employees eighteen years of age and older; to provide that the legislature
6	shall provide for certain definitions and exemptions; to provide relative to certain
7	student employees; to provide relative to certain tip credits available to employers;
8	and to specify an election for submission of the proposition to electors and provide
9	a ballot proposition.
10	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members
11	elected to each house concurring, that there shall be submitted to the electors of the state, for
12	their approval or rejection in the manner provided by law, a proposal to add Article XII,
13	Section 17 of the Constitution of Louisiana, to read as follows:
14	<u>§17. State Minimum Hourly Wage</u>
15	Section 17. On and after January 1, 2015, every employer with fifty or
16	more full-time employees shall pay to each employee eighteen years of age and
17	older a minimum hourly wage of not less than nine dollars and fifty cents per

1	hour, thereafter annually adjusted for inflation, or the federal minimum wage,
2	whichever is higher. The legislature shall provide for definitions and for certain
3	exemptions from the minimum wage requirement to include but not be limited
4	to student employees as defined in State Civil Service Rule 1.5.1 and allowing
5	an employer to take a tip credit toward its minimum wage obligation for tipped
6	employees equal to the difference between the required cash wage and the
7	required minimum wage.
8	Section 2. Be it further resolved that this proposed amendment shall be submitted
9	to the electors of the state of Louisiana at the statewide election to be held on November 4,
10	2014.
11	Section 3. Be it further resolved that on the official ballot to be used at said election
12	there shall be printed a proposition, upon which the electors of the state shall be permitted
13	to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as
14	follows:
15	Do you support an amendment to establish effective January 1, 2015 that
16	every employer with fifty or more employees shall pay each employee
17	eighteen years of age and older a minimum hourly wage of nine dollars and
18	fifty cents an hour, adjusted each year after that for inflation, or the federal
19	minimum wage, whichever is higher, and to require the legislature to provide
20	for definitions and certain exemptions, including but not limited to student
21	employees and allowing an employer to take a tip credit toward its minimum
22	wage obligation for tipped employees equal to the difference between the
23	required cash wage and required minimum wage?

## DIGEST

<u>Proposed constitutional amendment</u> provides that, effective January 1, 2015, every employer with 50 or more full-time employees shall pay to each employee 18 years of age and older a minimum hourly wage of not less than \$9.50 per hour, thereafter annually adjusted for

<u>Proposed constitutional amendment</u> further provides that the legislature shall provide for definitions and for certain exemptions from the minimum wage requirement to include but not be limited to student employees and allowing an employer to take a tip credit toward its minimum wage obligation for tipped employees equal to the difference between the required cash wage and the required minimum wage.

Specifies submission of the amendment to the voters at the statewide election to be held on November 4, 2014.
