MOTOR CARRIERS: Requires a person applying for a commercial driver's license to provide a current medical examiner's certificate

AN ACT

2 To amend and reenact R.S. 32:403.4(A)(1), relative to medical evaluation reports required 3 of persons driving a commercial motor vehicle; and to provide for related matters. 4 Be it enacted by the Legislature of Louisiana: 5 Section 1. R.S. 32:403.4(A)(1) is hereby amended and reenacted to read as follows: §403.4. Medical evaluation report required of persons driving a commercial motor 6 7 vehicle 8 A.(1) A person applying for a Class "A", "B", or "C" commercial driver's 9 license shall not have any physical or mental disability affecting the ability to 10 exercise ordinary and reasonable control in the operation of a commercial motor 11 vehicle. Such person, unless exempted by the office of motor vehicles or by a rule 12 or regulation, shall provide a current medical report medical examiner's certificate, 13 on a form approved by the office of motor vehicles, prepared by a duly licensed 14 medical examiner, certifying that he is capable of exercising ordinary and reasonable 15 control in the operation of a commercial motor vehicle. Such person shall submit a 16 valid medical report medical examiner's certificate at every renewal and shall carry 17 a current medical examiner's certificate on his person at all times when driving a commercial motor vehicle requiring either a Class "A", "B", or "C" commercial 18 19 driver's license as defined herein. 20

Abstract: Requires a person applying for a commercial driver's license to provide a current medical examiner's certificate on an approved form.

<u>Present law</u> requires a person applying for a commercial driver's license to provide a current medical report on a form approved by the office of motor vehicles. The applicant shall submit a valid medical report upon each renewal and carry a current medical certificate on his person at all times when driving a commercial motor vehicle.

<u>Proposed law</u> modifies <u>present law</u> by requiring a person applying for a commercial driver's license provide a current medical examiner's certificate on a form approved by the office of motor vehicles. Requires the applicant submit a valid medical examiner's certificate upon each renewal and carry a current medical examiner's certificate on his person at all times when driving a commercial motor vehicle.
