WEAPONS/FIREARMS: Creates an exception to the crime of carrying a concealed weapon on a school campus for concealed weapons holders who are teachers or administrators of certain schools

2	To amend and reenact R.S. 40:1379.3(N)(11) and to enact R.S. 14:95.2(C)(9), relative to
3	carrying a firearm on school property; to provide an exception for administrators and
4	teachers on the campus of an elementary, secondary, or high school campus who
5	possess a concealed handgun permit; to create exceptions regarding where concealed
6	handguns may be carried; to provide for additional training; to provide for
7	applicability; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 14:95.2(A)(C)(9) is hereby enacted to read as follows:
10	§95.2. Carrying a firearm or dangerous weapon by a student or nonstudent on
11	school property, at school-sponsored functions, or in a firearm-free zone

13	C. The provisions of this Section shall not apply to:

15	(9) A teacher or administrator of an elementary, secondary, or high school
16	who has been issued a concealed handgun permit pursuant to R.S. 40:1379.1 or R.S.
17	40:1379.3 while on school property, at a school sponsored function, or in a firearm-
18	free zone where the teacher or administrator is employed. The carrying of a
19	concealed handgun pursuant to the provisions of this Paragraph shall require those

1	teachers or administrators to complete an additional eight-hour tactical training prior
2	to carrying a concealed handgun on school property. The training shall be conducted
3	annually. Nothing in this Paragraph shall be construed to limit the right of a school

5	possessing a concealed handgun permit from carrying a firearm on school property.

**Abstract:** Creates an exception to the crime of carrying a firearm on an elementary, secondary, or high school campus for teachers or administrators of those schools who possess a concealed handgun permit.

<u>Present law</u> creates the crime of carrying of a firearm or dangerous weapon on school property.

<u>Present law</u> defines "school" as any elementary, secondary, high school, vocational-technical school, college, or university in this state.

<u>Present law</u> contains exceptions to the prohibition against carrying firearms on school property.

<u>Proposed law</u> adds as an exception to the crime of carrying a firearm or dangerous weapon on school property when the person carrying the firearm is a teacher or administrator of that school who has been issued a concealed handgun permit.

<u>Proposed law</u> requires an annual eight-hour tactical training for those teachers or administrators prior to being able to carry a concealed handgun on school property.

Provides that <u>proposed law</u> shall not be construed to limit the right of a school governing body or administration to prohibit or restrict access of those persons possessing a concealed handgun permit from carrying a firearm on school property.
