AN ACT

To amend and reenact R.S. 22:1007(I) and to enact R.S. 22:1007(J), relative to substitution of medications; to provide for requirements of provider contracts; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 22:1007(I) is hereby amended and reenacted, and R.S. 22:1007(J) is hereby enacted to read as follows:

§1007. Requirements of provider contracts; communications

* * *

I. Notwithstanding any provision of law to the contrary, any contract or agreement between a managed care organization and a health care provider shall include provisions that provide for the reimbursement of a health care provider in any instance in which the managed care organization requests or requires substitution of a medication for an enrollee.

~~I.J.~~ Any contract provision, written policy, or written procedure in violation of this Section shall be deemed to be unenforceable and null and void.
