Present law provides for the Louisiana Catfish Promotion and Research Program with the purpose of providing a voluntary method of raising revenues for developing markets and funding research and educational activities for the Louisiana catfish industry. Proposed law repeals all provisions of present law. Effective upon the governor's signature.
