Provides relative to alternative nicotine products

Present law provides for the unlawful possession, sales, purchase, and distribution of tobacco products to minors. Proposed law adds alternative nicotine products to the present law prohibitions. Present law provides in order to prevent persons under the age of 18 years of age from purchasing or receiving tobacco products from vending machines or self-service displays, the sale or delivery of tobacco products through a vending machined or self-service display is prohibited. Proposed law adds alternative nicotine products to the present law prohibitions. Effective upon signature of governor or lapse of time for gubernatorial action.
