SUPPLEMENTAL PAY: Increases the number of authorized Coushatta Indian tribal officers eligible for state supplemental pay

2	To amend and reenact R.S. 33:2218.2(F)(3), relative to state supplemental compensation for
3	certain law enforcement officers; to increase the number of Coushatta Indian tribal
4	officers eligible for additional compensation; to delete certain limitations; to provide
5	for an effective date; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 33:2218.2(F)(3) is hereby amended and reenacted to read as follows:
8	§2218.2. Rate of compensation; prior service; supplemental monthly compensation;
9	police to receive additional compensation

13	(3) Notwithstanding any other provision of law to the contrary, the
14	compensation for tribal officers of the Coushatta Indian Tribe of Louisiana shall be
15	for no more than eight sixteen such law enforcement officers, subject to approval by
16	the sheriff of Allen Parish.

18	Section 2. This Act shall become effective on July 1, 2014; if vetoed by the governor
19	and subsequently approved by the legislature, this Act shall become effective on July 1,
20	2014, or on the day following such approval by the legislature, whichever is later.

Abstract: Increases the number of Coushatta Indian tribal officers eligible for supplemental pay <u>from</u> eight <u>to</u> sixteen and deletes the requirement that the Allen Parish sheriff approve such pay.

<u>Present law</u> provides state supplemental pay of \$500 per month to qualified full-time police officers who have completed one year of service, are employed full-time by a municipality or certain tribes, and, if hired after March 31,1986, are certified by the Council on Peace Officers Standards and Training (P.O.S.T. certified).

<u>Present law</u> limits the number of tribal officers from the Coushatta Tribe of La. eligible for supplemental pay to eight. Further requires the sheriff of Allen Parish to approve the compensation of the Coushatta tribal officers.

<u>Proposed law</u> increases the number of eligible officers for the Coushatta Tribe of La. <u>from</u> eight to 16. Further deletes the requirement that the sheriff of Allen Parish approve the compensation of Coushatta tribal officers.

Effective on July 1, 2014.
