APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against DOTD in the matter of "Rena Ford Harrell, et al v. State Farm Automobile Insurance Company, et al" c/w "Rena Ford Harrell, et al v. State Farm Automobile Insurance Company, et al"

1	AN ACT
2	To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2014-
3	2015 to be used to pay the consent judgment against the Department of
4	Transportation and Development in the suit entitled "Rena Ford Harrell, et al v. State
5	Farm Mutual Automobile Insurance Company, et al" consolidated with "Rena Ford
6	Harrell, et al v. State Farm Mutual Automobile Insurance Company, et al"; and to
7	provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. The sum of Three Hundred Fifty Thousand and No/100 (\$350,000.00)
10	Dollars is hereby appropriated out of the General Fund of the state of Louisiana for Fiscal
11	Year 2014-2015 to be used to pay the consent judgment against the Department of
12	Transportation and Development in the suit entitled "Rena Ford Harrell, et al v. State Farm
13	Mutual Automobile Insurance Company, et al" consolidated with "Rena Ford Harrell, et al
14	v. State Farm Mutual Automobile Insurance Company, et al", bearing Numbers 233,753 "C"
15	and 234,456 "G", respectively, on the docket of the Ninth Judicial District Court, parish of
16	Rapides, state of Louisiana.
17	Section 2. This Act shall become effective on July 1, 2014; if vetoed by the governor
18	and subsequently approved by the legislature, this Act shall become effective on July 1,
19	2014, or on the day following such approval by the legislature, whichever is later.
