Abstract: Provides for an increase in truck registration fees.

<u>Present law</u> provides for the registration fees for motor trucks, tandem trucks, truck-tractors, or motor trucks, or truck-tractors used in combination with a trailer or semitrailer.

<u>Proposed law</u> increases the registration fees for trailers or semi-trailers in present law, based on truck weights, as follows: 6,000 or less from \$10 to \$20; 10,001 to 23,999 from 38¢ to 50¢ per 100 lbs; 24,000 to 37,999 from 60¢ to 72¢ per 100 lbs; 38,000 to 80,000 from 63¢ to 80¢ per 100 lbs; and 80,001 to 88,000 from 64¢ to 82¢ per 100 lbs.

Proposed law increases the registration fees for the use of trailers or semi-trailers in present law, based on truck weights, as follows: 6,000 or less for forest products (class 2) from \$10 to \$20, gravel haul (class 3) from \$10 to \$20, city use only (class 4) from \$10 to \$20, and farm trucks (class 5) from \$3 to \$6; 6,001 to \$10,000 for forest products (class 2) from 25¢ to 50¢ per 100 lbs, gravel haul (class 3) from 35¢ to 65¢ per 100 lbs, city use only (class 4) from 25¢ to 50¢ per 100lbs, and farm trucks (class 5) from \$3 to \$6, 10,001 to 23,999 for forest products (class 2) from 25¢ to 50¢ per 100 lbs, gravel haul (class 3) from 35¢ to 65¢ per 100 lbs, city use only (class 4) from 25¢ to 50¢ per 100 lbs, farm trucks (class 5) from \$10 to \$20; 24,000 to 43,999 for forest products (class 2) from 28¢ to 54¢ per 100 lbs, gravel haul (class 3) from 60¢ to 90¢ per 100 lbs, city use only (class 4) from 30¢ to 60¢ per 100 lbs, and farm trucks (class 5) from \$20 to \$30; 44,000 to 65,999 for forest products (class 2) from 28¢ to 54¢ per 100 lbs, gravel haul (class 3) from 60¢ to 90¢ per 100 lbs, city use only (class 4) from 30¢ to 90¢ per 100 lbs, and farm trucks (class 5) from \$30 to \$40; and 66,000 to 88,000 for forest products (class 2) from 28¢ to 54¢ per 100 lbs, gravel haul (class 3) from $60 \notin to 90 \notin to 100$ lbs, city use only (class 4) from $30 \notin to 60 \notin to 100$ lbs, and farm trucks (class 5) from \$40 to \$50.
