SENATE BILL NO. 590

SPECIAL DISTRICTS. Provides relative to the Oak Island Neighborhood Improvement District. (gov sig)

1 AN ACT

2 To amend and reenact R.S. 33:9091.15(D)(1) and (3), relative to the Oak Island
3 Neighborhood Improvement District; to provide for the governance; to provide for
4 commission membership; to provide for an effective date; and to provide for related
5 matters.

6 Notice of intention to introduce this Act has been published.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 33:9091.15(D)(1) and (3) are hereby amended and reenacted to read
9 as follows:

10 §9091.15. Oak Island Neighborhood Improvement District

11 * * *

12 D. Governance. (1) The district shall be governed by a ~~six~~ seven-member
13 board of commissioners, referred to in this Section as the "commission;" ~~which shall~~
14 ~~be appointed by the board of directors of the Oak Island Neighborhood Association.~~
15 ~~These appointed commissioners shall not be members of the Oak Island~~
16 ~~Neighborhood Association board of directors.~~ **The president of the Oak Island**
17 **Neighborhood Association or his designee shall serve as a member and six**

1 **additional members shall be appointed by the board of directors of the Oak**
2 **Island Neighborhood Association.**

3 * * *

4 (3)(a) Commissioners **appointed by the board of directors of the Oak**
5 **Island Neighborhood Association** shall serve two-year terms.

6 (b) **The president of the Oak Island Neighborhood Association or his**
7 **designee shall serve during his term of office.**

8 (c) Any vacancy which occurs prior to the expiration of the terms for a
9 commissioner shall be filled for the remainder of the unexpired term in the same
10 manner as the original appointment. Commissioners shall be eligible for
11 reappointment.

13 Section 2. This Act shall become effective upon signature by the governor or, if not
14 signed by the governor, upon expiration of the time for bills to become law without signature
15 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
16 vetoed by the governor and subsequently approved by the legislature, this Act shall become
17 effective on the day following such approval.

DIGEST

Morrell (SB 590)

Present law provides for six members to serve as the board of commissioners of the Oak
Island Neighborhood Improvement District.

Present law prohibits commissioners of the Oak Island Neighborhood Improvement District
to serve as members of the Oak Island Neighborhood Association board of directors.

Proposed law provides for the president of the Oak Island Neighborhood Association or his
designee to serve as a member of the board of commissioners of the Oak Island
Neighborhood Improvement District.

Proposed law provides for the president of the Oak Island Neighborhood Association or his
designee to serve during the president's term of office.

Effective upon signature of the governor or lapse of time for gubernatorial action.
