COURTS: Authorizes the collection of court costs in all district and parish courts to fund certain specialized divisions

| 8 | Be it enacted by the Legislature of Louisiana: |
| 9 | Section 1. R.S. 13:587.5 and 2565 are hereby enacted to read as follows: |
| 10 | §587.5. District courts; specialized divisions; additional costs; certain violations |
| 11 | A. Notwithstanding any other provision of law to the contrary, and in |
| 12 | addition to any fines, forfeitures, costs, or penalties, a judge in a district court with |
| 13 | a specialized alcohol division as defined in this Section may assess the following |
| 14 | additional costs to any person convicted of the following offenses: |
| 15 | (1) One hundred dollars for a violation of R.S. 14:98 or 98.1, prohibiting the |
| 16 | operation of a motor vehicle while under the influence of alcohol or drugs. |
| 17 | (2) One hundred dollars for a violation of R.S. 14:99, or any municipal or |
| 18 | parochial ordinance prohibiting the reckless operation of a motor vehicle. |

| 1 | (3) Fifty dollars for a violation of R.S. 14:92, 93.11, 93.12, or 333, or of any |

| 14 | B. For purposes of this Section, a district court with a specialized alcohol |

| 20 | C. Any district court with a specialized alcohol division or section shall |
| 21 | establish a fund to deposit all fees collected pursuant to this Section. All funds |
| 22 | collected shall be used solely for the purposes of funding the approved alcohol or |
| 23 | driving while intoxicated division or section and any treatment programs and |
| 24 | administrative expenses associated with the program. |
| 25 | D. In the event that an individual is unable to pay the cost when assessed, the |
| 26 | court may allow payment to be deferred within a certain time frame, based on the |
| 27 | person's ability to pay the costs. |

Abstract: Authorizes judges of district or parish courts with specialized subject matter jurisdiction to assess certain costs for certain alcohol-related violations.

<u>Proposed law</u> provides that in addition to any fines, forfeitures, costs, or penalties, a judge in a district or a parish court with a specialized alcohol division or a parish court that has within the judicial district, a specialized alcohol division, may assess any of the following additional court costs to any person convicted of certain offenses:

- (1) \$100 for violation of <u>present law</u> or of any municipal or parochial ordinance prohibiting the operation of a motor vehicle while under the influence of alcohol or drugs or underage driving under the influence.
- (2) \$100 for a violation of <u>present law</u> or of any municipal or parochial ordinance prohibiting the reckless operation of a motor vehicle.
- (3) \$50 for a violation of <u>present law</u> or of any municipal or parochial ordinance prohibiting the contributing to delinquency of juveniles, improper supervision of a minor by parent or custodian, or purchase or public possession of alcoholic beverages by persons under the age of 21-years old.
- (4) \$25 for a violation of <u>present law</u> or of any municipal or parochial ordinance prohibiting the unauthorized possession or consumption of alcoholic beverages on public school property, public drinking, public possession of alcohol or appearing in an intoxicated condition in public, disturbing the peace, or vagrancy.
- (5) \$25 for a violation of <u>present law</u> or of any municipal or parochial ordinance prohibiting the possession of open alcoholic beverage containers in vehicles.
- (6) \$25 for all other convictions of a felony, misdemeanor, or any municipal or parochial ordinance, including a traffic felony, misdemeanor, or a local traffic violation where the use of alcohol was a factor in the commission of the crime.

<u>Proposed law</u> defines a specialized alcohol division as a district or parish court that designates by court rule a division or section of the court which has subject matter jurisdiction for alcohol-related offenses, including driving while intoxicated and is approved or certified by the La. Highway Safety Commission and the La. Supreme Court.

<u>Proposed law</u> requires any district or parish court that collects fees pursuant to <u>proposed law</u> to deposit the monies into a special fund to be used solely for funding the designated and

approved alcohol or driving while intoxicated division and any treatment programs and associated administrative expenses.
