Prohibits the State Board of Elementary and Secondary Education from authorizing charter schools under certain circumstances

The proposed legislation prohibits the Board of Elementary and Secondary Education (BESE) from entering into a charter if the proposed school would be located in a school system that received a letter grade of "A", "B", or "C" in its most recent evaluation and the school board has previously denied or placed conditions on the same or similar proposal.

**EXPENDITURE EXPLANATION**

There is an indeterminable impact as a result of this measure. The proposed legislation would not impact the amount of MFP funding distributed to the school system, but could impact the amounts distributed to the schools within the district if a charter school were not approved. The 2011-2012 District Performance Scores posted on the Department of Education (DOE) website reported 43 districts with a grade of "A", "B" or "C". The DOE did not provide information on how many authorized charters from these districts had been approved by BESE which may have been previously rejected by the local school board.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
