4	WHEREAS, it is with great pride that the citizens of Louisiana and the Senate of the
5	Legislature of Louisiana recognize CASA Child Advocate of the Year, James Evans; and
6	WHEREAS, Louisiana's citizens pride themselves on giving back to their
7	communities by contributing to the quality of life of our citizens, and eighty-nine year old
8	James Evans is no different; and
9	WHEREAS, in association with the national organization, Court Appointed Special
10	Advocate (CASA) programs across Louisiana speak for the best interests of abused and
11	neglected children who are under the purview of juvenile courts; and

13	background and child abuse registry checks, are judge-sworn officers of the court, and work

15	of the child's life, and
16	WHEREAS, it is often said the advocates are the eyes and ears for the judge in cases
17	where the Department of Child and Family Services has removed the child from the home
18	due to abuse or neglect; and

2	volunteer and give of himself, serving as a powerful voice for the needy children of
3	Louisiana; and
4	WHEREAS, Mr. Evans often takes another case immediately after a case is closed
5	due to reunification, adoption, or transferred custody, and he is currently working on his
6	third case in a two-year period; and
7	WHEREAS, Mr. Evans prides himself on being a voice for those who cannot be
8	heard, and is always eager to help children find a safe, permanent, and nurturing home as
9	quickly as possible; and
10	WHEREAS, his volunteering does not stop with CASA as he also volunteers for the
11	Salvation Army and Kairos, a ministry that assists inmates in transitioning to productive
12	citizens, and through Kairos, he does weekend and week-long retreats; and
13	WHEREAS, Mr. Evans has acquired a great deal of experience and wisdom through
14	his years, is a wonderful, caring person who enjoys helping and dedicating his time
15	volunteering and mentoring, has written two books about his life, and is truly committed to
16	all things in which he is involved; and
17	WHEREAS, the success of the state of Louisiana, the strength of our communities,
18	and the overall vitality of American society depends, in great measure, upon the character
19	of men like James Evans who dedicate their lives to volunteering and helping others.
