SENATE BILL NO. 403

HEALTH/ACC INSURANCE. Provides relative to third party payments of health insurance premiums of individuals with HIV/AIDS. (8/1/14)

1 AN ACT

2 To enact R.S. 22:1080, relative to third party premium payments; to provide with respect to
3 insurers acceptance of third party premium payments; to require acceptance of
4 premium payments from certain state, federal, or tribal programs or publicly
5 supported charities; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 22:1080 is hereby enacted to read as follows:

8 **§1080. Third party premium payments; refusal of acceptance**

9 **A. No health insurance issuer or health maintenance organization shall**
10 **refuse the receipt of a premium payment when such payment is made by a third**
11 **party to the insurance contract, provided that the payment is made from or**
12 **pursuant to a fund or grant established by any one of the following:**

13 **(1) The Ryan White HIV/AIDS Program pursuant to Title XXVI of the**
14 **Public Health Services Act.**

15 **(2) Indian tribes, tribal organizations, or urban Indian organizations.**

16 **(3) State or federal government programs.**

17 **(4) Publicly supported charities within the meaning of Sections 501(c)(3)**

- 1 **and 170(b)(1)(A)(vi) of the United States Internal Revenue Code.**
- 2 **B. This Section shall not be construed to require a health insurance**
- 3 **issuer or health maintenance organization to accept a third party premium**
- 4 **payment from a health care provider.**

DIGEST

Mills (SB 403)

Proposed law prohibits a health insurance issuer or health maintenance organization from refusing to accept premium payments when such payment is made by a third party to the insurance contract, provided that the payment is made from any of the following:

- (1) The Ryan White HIV/AIDS Program pursuant to Title XXVI of the Public Health Services Act.
- (2) Indian tribes, tribal organizations, or urban Indian organizations.
- (3) State or federal government programs.
- (4) Publicly supported charities within the meaning of Sections 501(c)(3) and 170(b)(1)(A)(vi) of the United States Internal Revenue Code.

Effective August 1, 2014.

Summary of Amendments Adopted by Senate

Committee Amendments Proposed by Senate Committee on Insurance to the original bill.

1. Requires acceptance of premium payments from any of the following:
 - (a) The Ryan White HIV/AIDS Program pursuant to Title XXVI of the Public Health Services Act.
 - (b) Indian tribes, tribal organizations, or urban Indian organizations.
 - (c) State or federal government programs.
 - (d) Publicly supported charities within the meaning of Sections 501(c)(3) and 170(b)(1)(A)(vi) of the United States Internal Revenue Code.
