Creates an exception to the crime of carrying a concealed weapon on a school campus for concealed weapons holders who are teachers or administrators of certain schools

Proposed law adds an exception to the crime of carrying a firearm or dangerous weapon on school property when the person carrying the firearm is a teacher or administrator of that school who has been issued a concealed handgun permit. Requires an annual eight-hour tactical training for those teachers or administrators prior to being able to carry a concealed handgun on school property.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The proposed law adds an exception to the crime of carrying a firearm or dangerous weapon on school property when the person carrying the firearm is a teacher or administrator of that school who has been issued a concealed handgun permit. The cost of the eight-hour tactical training will be borne by the concealed handgun holder.

Note: The LFO is unaware of who will provide the tactical training provided for in the proposed legislation.
