FISHING/CRABS: To require the Wildlife and Fisheries Commission to establish a program to enhance and elevate professionalism in the commercial crab industry

AN ACT

2 To amend and reenact R.S. 56:305.6, relative to commercial crab fishing; to provide for an 3 apprenticeship entry into the fishery; and to provide for related matters. 4 Be it enacted by the Legislature of Louisiana: 5 Section 1. R.S. 56:305.6 is hereby amended and reenacted to read as follows: §305.6. Moratorium on crab trap gear licenses Commercial crab fishing; apprentice 6 7 license; requirements 8 For commercial license year 2005, no person shall be issued a commercial 9 crab trap gear license unless that person possessed a valid commercial crab trap gear 10 license during any one of the years 2002, 2003, or that portion of 2004 prior to 11 November 15, 2004. 12 A. The commission shall establish a program to increase and elevate 13 professionalism in the commercial crab industry. Such professionalism program 14 shall include education in the proper fishing techniques necessary for the health and 15 sustainability of the species; proper techniques for the best capture and presentation 16 of the crabs for marketability; proper instructions regarding the placement, tending, 17 and maintenance of crab traps to reduce potential conflicts with other user groups; and may include an apprenticeship program. The professionalism program shall be 18 established no later than November 15, 2014, through rules promulgated pursuant 19 to the Administrative Procedure Act. 20

12	vetoed by the governor and subsequently approved by the legislature, this Act shall become
13	effective on the day following such approval.

Abstract: Requires the Wildlife and Fisheries Commission to establish a program to enhance and elevate professionalism in the commercial crab industry.

<u>Proposed law</u> requires the Wildlife and Fisheries Commission to establish a program to increase and elevate professionalism in the commercial crab industry. Requires the program to include education in the proper fishing techniques necessary for the health and sustainability of the species; proper techniques for the best capture and presentation of the crabs for marketability; proper instructions regarding the placement, tending, and maintenance of crab traps to reduce potential conflicts with other user groups; and authorizes the program to include an apprenticeship program. Requires that the professionalism program be established no later than Nov. 15, 2014, through rules promulgated pursuant to the Administrative Procedure Act.

<u>Proposed law</u> provides that beginning Nov. 15, 2014, and applicable to license year 2015 and thereafter, no person can be issued a commercial crab trap gear license unless that person qualifies under one or both of the following provisions:

(1) The person possessed a valid commercial crab trap gear license during any two license years between 2011 and 2014.

(2) The person has enrolled in and completed the program to increase and elevate professionalism in the commercial crab industry established pursuant to the provisions of this Section.

Effective upon signature of governor or lapse of time for gubernatorial action.
