HEALTH CARE: Provides relative to criminal background checks of ambulance personnel

AN ACT

2	To amend and reenact R.S. 40:1300.53(A)(1) and to enact R.S. 40:1300.53(A)(3) and (4),
3	relative to ambulance personnel; to prohibit the hiring of licensed ambulance
4	personnel and nonlicensed persons with a conviction of certain crimes; to provide for
5	retroactive application; to provide for an effective date; and to provide for related
6	matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 40:1300.53(A)(1) is hereby amended and reenacted and R.S.
9	40:1300.53(A)(3) and (4) are hereby enacted to read as follows:
10	§1300.53. Refusal to hire or contract; termination of employment; exemption;
11	appeal procedure; waiver
12	A. Except as otherwise provided in R.S. 40:1300.52(C), no employer shall
13	hire any licensed ambulance personnel or nonlicensed person when the results of a
14	criminal history check reveal that the licensed ambulance personnel or nonlicensed
15	person has been convicted of any of the following offenses:
16	(1) R.S. 14:28.1, 30, 30.1, 31, 32.6, 32.7, 32.12, 34, 34.1, 34.7, 35.2, 37,
17	37.1, 37.4, 38.1, 42, 42.1, 43, 43.1, 43.2, 43.3, 43.5, 44, 44.1, 46.2, 51, 60, 62.1, 64,
18	64.1, 64.4, 66, 67.21, 89, 89.1, 93.3, 93.4, 93.5 or distribution or possession with the
19	intent to distribute controlled dangerous substances as listed in Schedules I through

1	(3) The felony offense involving theft, pursuant to R.S. 14:67, or theft of
2	assets of an aged person or disabled person, pursuant to R.S. 14:67.21 in excess of
3	five hundred dollars or in any case in which the offender has been previously
4	convicted of theft, pursuant to R.S. 14:67, or theft of assets of a person who is aged
5	or a person with disability, pursuant to R.S. 14:67.21, regardless of the value of the
6	instant theft.
7	(4) An attempt or conspiracy to commit an offense listed in Paragraph (3) of
8	this Subsection.

10	Section 2. The provisions of this Act shall be given retroactive application.
11	Section 3. This Act shall become effective upon signature by the governor or, if not
12	signed by the governor, upon expiration of the time for bills to become law without signature
13	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
14	vetoed by the governor and subsequently approved by the legislature, this Act shall become
15	effective on the day following such approval.

Alfred Williams HB No. 487

Abstract: Prohibits the hiring of ambulance personnel with a criminal conviction involving the felony offense of theft or the theft of assets of an aged person or disabled person.

<u>Present law</u> prohibits an employer from hiring any licensed ambulance personnel or nonlicensed person when the results of a criminal history check reveal that the licensed ambulance personnel or nonlicensed person has been convicted of the theft of the assets of an aged person or disabled person.

<u>Proposed law</u> amends <u>present law</u> to prohibit an employer from hiring any licensed ambulance personnel or nonlicensed person when the results of a criminal history check reveal that the licensed ambulance personnel or nonlicensed person has been convicted of a felony offense involving theft (R.S. 14:67) or theft of assets of an aged person or disabled person (R.S. 14:67.21) in excess of \$500 or in any case in which the offender has been previously convicted of theft or theft of assets of a person who is aged or a person with a disability regardless of the value of the instant theft.

Proposed law provides for retroactive application of proposed law.

Effective upon signature of governor or lapse of time for gubernatorial action.

(Amends R.S. 40:1300.53(A)(1); Adds R.S. 40:1300.53(A)(3) and (4))
