1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S." delete the remainder of the line and delete lines 3 through 6  
3 in their entirety and insert the following:

4 "32:412(A)(1),(2),(3),(4)(a) and (b)(introductory paragraph), (5), (6), (7)(a)  
5 and (b)(introductory paragraph), (B)(1), (2), (5), (7)(a)(i) and (ii)(introductory  
6 paragraph), (b)(i) and (ii)(introductory paragraph), (c)(i) and (ii)(introductory  
7 paragraph), (d)(i) and (ii)(introductory paragraph), (e)(i)(aa), (bb)(introductory  
8 paragraph), (cc), (dd), and (ee), and (ii)(aa), (cc),(dd) and (ee) and (C),  
9 32:412.1(B)(C)(D), and 32:429(A), to enact R.S. 32:412(M) and 32:412.1(E), and  
10 to repeal R.S. 32:412.1(A)(1), relative to the duration of driver's"

11 AMENDMENT NO. 2

12 On page 1, line 10, after "R.S." delete the remainder of the line and delete lines 11 through  
13 14 in their entirety and insert the following:

14 "32:412(A)(1),(2),(3),(4)(a) and (b)(introductory paragraph), (5), (6), (7)(a)  
15 and (b)(introductory paragraph), (B)(1), (2), (5), (7)(a)(i) and (ii)(introductory  
16 paragraph), (b)(i) and (ii)(introductory paragraph), (c)(i) and (ii)(introductory  
17 paragraph), (d)(i) and (ii)(introductory paragraph), (e)(i)(aa), (bb)(introductory  
18 paragraph), (cc), (dd), (ee), and (ii)(aa), (cc)(dd), and (ee) and (C),  
19 32:412.1(B)(C)(D), and 32:429(A) are hereby amended and reenacted and R.S.  
20 32:412(M) and 32:412.1(E) are hereby enacted to read as"

21 AMENDMENT NO. 3

22 On page 1, line 20, after "A." insert the following:

23 "(1) Every applicant for a Class "D" driver's license, or for a renewal of a  
24 Class "D" driver's license, except those bona fide residents of the city of New  
25 Orleans, shall pay for such basic license a fee of ~~twenty-eight dollars and fifty cents~~  
26 forty-two dollars and seventy five cents. ~~Seven dollars and forty three cents~~ Eleven  
27 dollars and fifteen cents of the fee shall be paid to the State Police Pension and  
28 Retirement Fund. One dollar and fifty cents of the fee shall be forwarded by the  
29 department to the litter abatement and education account which is created with the  
30 Conservation Fund through the provisions of R.S. 56:10(B)(15).

31 (2) The fee for Class "D" driver's licenses, or renewal of a Class "D" driver's  
32 license, issued to bona fide residents of the city of New Orleans shall be ~~thirty-six~~  
33 ~~dollars~~ fifty-four dollars, ~~ten dollars~~ fifteen dollars of which shall be payable by the  
34 department to the board of trustees of the police pension fund of the city of New  
35 Orleans. One dollar and ~~twenty three cents~~ eighty four cents of the fee shall be paid  
36 to the State Police Pension and Retirement Fund. One dollar and fifty cents of fee  
37 shall be forwarded by the department to the litter abatement and education account  
38 which is created within the Conservation Fund through the provisions of R.S.  
39 56:10(B)(15).

40 (3) There shall be a fee of ~~five dollars~~ seven dollars and fifty cents for an  
41 emergency vehicle endorsement for any vehicle group."

1 AMENDMENT NO. 4

2 On page 2, between lines 9 and 10, insert the following:

3 (5) Every applicant for a Class "E" driver's license, or for a renewal of a  
 4 Class "E" driver's license, except those bona fide residents of the city of New  
 5 Orleans, shall pay for such basic license a fee of ~~thirteen dollars and fifty cents~~  
 6 twenty dollars and twenty-five cents, which shall be the cost of such basic license.  
 7 ~~Three dollars and seventy-five cents~~ Five dollars and sixty-three cents of the fee shall  
 8 be paid to the State Police Pension and Retirement Fund. One dollar and fifty cents  
 9 of the fee shall be forwarded by the department to the litter abatement and education  
 10 account which is created within the Conservation Fund through the provisions of  
 11 R.S. 56:10(B)(15).

12 (6) The fee for a Class "E" driver's license, or renewal of a Class "E" driver's  
 13 license, issued to bona fide residents of the city of New Orleans shall be ~~thirteen~~  
 14 ~~dollars and fifty cents, two dollars and fifty cents~~ twenty dollars and twenty-five  
 15 cents, three dollars and seventy-five cents of which fee shall be paid by the  
 16 department to the board of trustees of the police pension funds of the city of New  
 17 Orleans. ~~Two dollars and fifty cents~~ Three dollars and seventy-five cents of the fee  
 18 shall be paid to the State Police Pension and Retirement Fund. One dollar and fifty  
 19 cents of the fee shall be forwarded by the department to the litter abatement and  
 20 education account which is created within the Conservation Fund through the  
 21 provisions of R.S. 56:10(B)(15)."

22 AMENDMENT NO. 5

23 On page 2, line 19, after "B." insert the following:

24 (1) Every applicant for a Class "A", "B", or "C" commercial driver's license,  
 25 or for a renewal of a basic Class "A", "B", or "C" commercial driver's license, except  
 26 for those bona fide residents of the city of New Orleans, shall pay for such basic  
 27 license a fee of ~~forty-one dollars. Ten dollars and eighty cents~~ sixty-one dollars and  
 28 fifty cents. Sixteen dollars and twenty cents of the fee shall be paid to the State  
 29 Police Pension and Retirement Fund. One dollar and fifty cents of the fee shall be  
 30 forwarded by the department to the litter abatement and education account which is  
 31 created within the Conservation Fund through the provisions of R.S. 56:10(B)(15).

32 (2) The fee for a basic Class "A", "B", or "C" commercial driver's license, or  
 33 for the renewal of a basic Class "A", "B", or "C" commercial driver's license, issued  
 34 to bona fide residents of the city of New Orleans shall be ~~fifty-one dollars, ten~~  
 35 ~~seventy-six dollars and fifty cents, fifteen dollars~~ of which fee shall be paid by the  
 36 department to the board of trustees of the police pension fund of the city of New  
 37 Orleans. ~~Ten~~ Fifteen dollars of the fee shall be paid to the State Police Pension and  
 38 Retirement Fund. One dollar and fifty cents of the fee shall be forwarded by the  
 39 department to the litter abatement and education account which is created with the  
 40 Conservation Fund through the provisions of R.S. 56:10(B)(15).

 43 endorsement to the basic licenses listed in R.S. 32:408(B).

11 On page 5, delete line 6 in its entirety and insert the following:

13 the fee shall be paid to the State Police Pension and Retirement Fund. ~~One dollar~~ and  
14 fifty cents of the fee shall be forwarded by the department to the litter abatement and  
15 education account which is created within the Conservation Fund through the  
16 provisions of R.S. 56:10(B)(15)."

24 cents of the fee shall be paid to the State Police Pension and Retirement Fund. ~~One~~  
25 dollar and fifty cents of the fee shall be forwarded by the department to the litter  
26 abatement and education account which is created within the Conservation Fund  
27 through the provisions of R.S. 56:10(B)(15)."

5 On page 6, after line 29, insert the following:

6 §412.1. Handling charges

7 \* \* \*

8 B. Except as provided in Subsection D, the officer of motor vehicles shall  
9 collect, in addition to any fee authorized by law, a handling charge of twelve dollars  
10 for each of the following transactions:

11 (1) Class D and Class E drivers' licenses:

12 (a) New applications.

13 (b) Renewals.

14 (c) Duplicates.

15 (d) Valid without photo.

16 ~~B.~~ C. Additional handling charges of eight dollars may be established by the  
17 office of motor vehicles upon transactions not specifically named in Subsection A  
18 of this Section in accordance with procedures in the Administrative Procedure Act.

19 ~~C.~~ D. Two Three dollars and seventy-five cents on Class "D" and "E"  
20 driver's license transactions, and two dollars and fifty cents of the fee charged for all  
21 other any handling fees charged or collected shall be forwarded to the state treasurer  
22 for deposit in to the Office of Motor Vehicles Customer Service and Technology  
23 Fund created pursuant to the provisions of R.S. 32:429.2.

24 ~~D.~~ E. A child who is in foster care, as defined in Article 603 of the Louisiana  
25 Children's Code, shall not be required to pay the handling fee or other charge in order  
26 to obtain a driver's license or identification card.

28 §32:429. Office of motor vehicles field offices; authorization of fees

29 A.(1) The governing authority of any local governmental subdivision is  
30 hereby authorized to levy, by resolution, a fee for each service or transaction carried  
31 out as an operation of an office of motor vehicles field office that is not fully funded  
32 by the state. Except as provided in Paragraph (2) of this Subsection, the fee shall not  
33 exceed ~~three dollars~~ four dollars and fifty cents per service or transaction and shall  
34 be used solely to defray the cost of operations of that local field office, including but  
35 not limited to facility rental, utilities, and maintenance. The fee shall not be charged  
36 for the procurement or renewal of a motor vehicle registration license.

37 (2) The fee provided for in Paragraph (1) of this Subsection may be levied in  
38 an amount not to exceed ~~four~~ six dollars by the local governing authority of Orleans  
39 Parish.

40 Section 2. R.S. 32:412.1(A)(1) is hereby repealed in its entirety.

41 Section 3. This Act shall become effective February 1, 2015."
