HOUSE BILL NO. 1091

ANIMALS: Prohibits the transportation of dogs in pickup truck beds on certain roadways unless humanely secured

AN ACT

2	To enact R.S. 32:284.1, relative to the transportation of dogs; to prohibit the transportation
3	of dogs in pickup truck beds on certain roadways; to provide exceptions; to provide
4	for penalties; to provide definitions; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 32:284.1 is hereby enacted to read as follows:
7	§284.1. Transporting dogs in pickup truck beds on interstate highways; generally
8	prohibited; exceptions
9	A.(1) No person shall be permitted to transport a dog or dogs in a pickup
10	truck bed on an interstate highway in this state.
11	(2) The provisions of this Section shall not apply if the dog or dogs are
12	transported in a secure, humane manner that prevents the dog or dogs from falling,
13	jumping, or being thrown from the pickup truck bed.
14	B.(1) Transporting one dog in violation of the provisions of this Section shall
15	be punishable by a fine of not more than one hundred fifty dollars.
16	(2) Transporting more than one dog at the same time in violation of this
17	Section shall be punishable by the fine imposed by Paragraph (1) of this Subsection
18	for any one of the dogs and a fifty-dollar fine for each additional dog.
19	C. The provisions of this Section shall apply only to dogs and not to any
20	other animal.

For the purposes of this Section, "humane manner" means the transport 2 of a dog or dogs in one of the following ways: 3 (1) Being physically inside of an enclosed container, crate, kennel, or cage, 4 that is safely secured to the inside of the bed of a pickup truck that provides adequate ventilation for the dog or dogs to maintain oxygen intake and breathe without 5 distress, and enough space for the dog or dogs to stand, sit, and turn around. 6 7 (2) Being physically restrained by a restraint system that is long enough to 8 allow the dog to move its head above its shoulders while standing and short enough 9 to prevent the dog from falling, jumping, or being thrown from the bed of the pickup 10 truck. For purposes of this Subsection, a "restraint system" means any apparatus 11 used for the purpose of restricting a dog's movements, which may consist of a collar, 12 harness, leash, lead, rope, tie out, or any other securing device, used independently 13 or collectively that does not cause any harm to the dog or dogs. 14 (3) Being physically enclosed in the bed of a pickup truck that is covered by 15 a ventilated top that prevents the dog or dogs from jumping, falling, or being thrown 16 from the bed of the pickup truck. The enclosed environment shall not cause harm 17 to the dog or dogs and shall provide them with enough room to stand up and move 18 around.

Willmott HB No. 1091

Abstract: Prohibits dogs from being transported in the back of pickup trucks on interstate highways unless humanely secured.

<u>Proposed law</u> prohibits drivers from transporting dogs in the back of pickup trucks on interstate highways within this state.

<u>Proposed law</u> defines "humane manner" and provides for exceptions relative to dogs that are secured in a humane manner in one of the following ways:

(1) Physically inside of an enclosed container, crate, kennel, or cage, that is safely secured to the inside of the bed of a pickup truck that provides adequate ventilation for the dog or dogs to maintain oxygen intake and breathe without distress, and enough space for the dog or dogs to stand, sit, and turn around.

- (2) Physically restrained by a restraint system that is long enough to allow the dog to move its head above its shoulders while standing and short enough to prevent the dog from falling, jumping, or being thrown from the bed of the pickup truck.
- (3) Physically enclosed in the bed of a pickup truck that is covered by a ventilated top that prevents the dog or dogs from jumping, falling, or being thrown from the bed of the pickup truck.

<u>Proposed law</u> defines "restraint system" as any apparatus used for the purpose of restricting a dog's movements, which may consist of a collar, harness, leash, lead, rope, tie out, or any other securing device, used independently or collectively that does not cause any harm to the dog or dogs.

<u>Proposed law</u> provides that the penalty for transporting one dog in violation of <u>proposed law</u> is a fine of not more than \$150.

<u>Proposed law</u> provides that an additional fine of \$50 per dog shall be imposed for each additional dog transported at the same time in violation of proposed law.
