

**HOUSE COMMITTEE AMENDMENTS**

Amendments proposed by House Committee on Labor and Industrial Relations to Engrossed Senate Bill No. 106 by Senator Walsworth

1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S. 23:1553(G)" delete "and" and insert a comma ","

3 AMENDMENT NO. 2

4 On page 1, line 2, after "R.S. 23:1514(E)" and before the comma "," insert "and R.S.  
5 49:191(7) and to repeal R.S. 49:191(5)(e)"

6 AMENDMENT NO. 3

7 On page 1, line 3, at the beginning of the line, insert the following:

8 "Louisiana Workforce Commission, including provisions to provide for the re-creation of  
9 the Louisiana Workforce Commission and the statutory entities made a part of the  
10 commission by law; to provide for the effective termination date for all statutory authority  
11 for the existence of such statutory entities; provides with respect to the"

12 AMENDMENT NO. 4

13 On page 2, delete lines 3 through 7 in their entirety and insert the following:

14 "Section 2. Pursuant to R.S. 49:193, the Louisiana Workforce Commission and the  
15 statutory entities made a part of the department by law shall be re-created effective June 30,  
16 2014, and all statutory authority therefor is continued in accordance with the provisions of  
17 Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

18 Section 3. All statutory authority for the existence of the Louisiana Workforce  
19 Commission and the statutory entities made a part of the department as re-created by Section  
20 1 of this Act shall cease as of July 1, 2019, pursuant to R.S. 49:191. However, the Louisiana  
21 Workforce Commission may be re-created prior to such date in accordance with the  
22 provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

23 Section 4. The provisions of R.S. 49:193 are hereby superseded to the extent that  
24 those provisions are in conflict with the provisions of this Act.

25 Section 5. R.S. 49:191(7) is hereby enacted to read as follows:

26 §191. Termination of legislative authority for existence of statutory entities; phase-  
27 out period for statutory entities; table of dates

28 Notwithstanding any termination dates set by any previous Act of the  
29 legislature, the statutory entities set forth in this Section shall begin to terminate their  
30 operations on July first of each of the following years, and all legislative authority  
31 for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of  
32 July first of the following year, which shall be the termination date:

34 (7) July 1, 2018:

35 (a) The Louisiana Workforce Commission and all statutory entities made a  
36 part of the department by law.

37 Section 6. R.S. 49:191(5)(e) is hereby repealed in its entirety.

38 Section 7. This Act shall become effective on June 30, 2014; if vetoed by the  
39 governor and subsequently approved by the legislature, this Act shall become effective on  
40 June 30, 2014, or on the day following such approval by the legislature, whichever is later."
