Provides relative to the title of proceedings for continuing tutorships

In present law, Civil Code Article 356 provides the title of the tutorship proceedings shall be "Continuing Tutorship of (Name of Person), A Mentally Retarded Person" and establishes procedural rules. Proposed law retains present law but deletes from the title "A Mentally Retarded Person".


EXPENDITURE EXPLANATION
