

1 WHEREAS, the Legislature of Louisiana recognizes and commends the role of
2 Medicare managed care plans that have served the highly vulnerable, at-risk Medicare
3 population in Louisiana, including dual eligibles, over the decades and have maintained
4 superior quality star ratings for their health plan services; and

5 WHEREAS, the Legislature of Louisiana directs the department in designing a
6 program to better coordinate the care of Louisiana's dual eligible population, while not
7 sacrificing the progress and quality of care already achieved by these existing Medicare
8 managed care plans.

9 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
10 urge and request the Department of Health and Hospitals to develop a plan by October 1,
11 2014, for the creation of a demonstration program to coordinate and integrate the health care
12 of Medicare-Medicaid dual eligibles with a Medicare managed care plan, as follows:

13 (1) The department is directed to consider any federal authority deemed most
14 appropriate to develop this pilot program.

15 (2) In developing the pilot program, the department shall consider the success of
16 Medicare managed care plans to provide effective and quality care to Louisianians and shall
17 not, in developing the plan, sacrifice the progress, quality, and enrollment already achieved
18 by existing Louisiana domiciled Medicare managed care plans.

19 (3) In developing the plan for the Medicare-Medicaid pilot program, the department
20 shall solicit and consider the comments and views of existing Medicare managed care plans.

21 (4) In developing the plan for the pilot program, the department shall take into
22 account those regions served by existing Medicare managed care plans with populations that
23 have a significant percentage of dual eligibles.

24 (5) In designing programs to better coordinate the care of Louisiana's dual eligible
25 population, the department shall not impair the right of its citizens to choose and retain
26 existing Medicare plans, that could result in the disruption of the care continuum, and the
27 reduction of health care choice and access for the citizens of Louisiana.

28 (6) The Legislature of Louisiana directs the department to provide dual eligible
29 individuals the opportunity to choose the demonstration program in lieu of any existing
30 Medicaid program or any future Medicaid program to be developed by the state of

1 Louisiana.

2 (7) No later than October 1, 2014, the secretary of the department shall submit a
3 written report regarding the plan for developing the demonstration program to the Senate
4 Committee on Health and Welfare and the House Committee on Health and Welfare,
5 including but not limited to the following:

6 (a) The extent to which the department considers any federal authority deemed most
7 appropriate to develop this demonstration program.

8 (b) The extent to which the department considers the views and comments of
9 existing Medicare managed care plans.

10 (c) Steps taken by the department to ensure a beneficiary affected by the
11 department's plans to better coordinate the care of Louisiana's dual eligible population while
12 maintaining the right to choose and retain existing Medicare health care plans.

13 (d) Steps taken by the department to ensure that the plan includes those regions of
14 the state served by existing Medicare managed care plans with populations that have a
15 significant percentage of dual eligibles.

16 (e) Steps taken by the department to protect the freedom of choice for a dual eligible
17 individual.

18 BE IT FURTHER RESOLVED that a copy of this Resolution shall be included on
19 the official website of Department of Health and Hospitals.

20 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
21 secretary of the Department of Health and Hospitals.
