Provides relative to instruction on dating violence in public schools

Current law requires school instruction on dating violence for public school students in grades seven through twelve. Proposed legislation requires the governing authority of each public school (including charters) to also provide related instruction to all school employees who have contact with students in these grades as well as information to the parents of those students. The instruction is to cover dating violence, warning signs, and how to properly address suspected or reported violence. Requires definitions and instructions in the student codes of conduct. Further requires the collection of certain data and for each local superintendent to provide verbal reports to the school's governing authority on an annual basis.

**EXPENDITURE EXPLANATION**

School systems' expenditures will increase to ensure that staff is provided professional development opportunities and parents are provided information regarding dating violence as required in the bill. Any increase is indeterminable and depends on the methods the school districts choose to provide these professional development opportunities. These methods may result in a range of costs from nominal to more significant if workshops are offered. Schools may also incur costs if new data collection methods must be established and implemented. Finally, systems will also realize an increased workload to update their code of conduct to incorporate the policies required in the legislation. Expenditures could be funded with a mix of state and local dollars from the MFP.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
