Brown (SB 281) Act No. 121

<u>Prior law</u> required each authorized insurer and each health maintenance organization licensed to operate in this state to prepare, implement, and maintain an insurance anti-fraud plan for operations in the state.

<u>New law</u> exempts a small company as defined in <u>prior law</u> from the requirement to have an anti-fraud plan.

Effective August 1, 2014.
