5 and an assistant executive director of the Lafourche Basin Levee District;"

9 On page 1, line 15, change "**shall**" to "**may**"

10 AMENDMENT NO. 5

13 On page 2, at the end of line 6, add "**The cooperative endeavor agreement shall provide**
14 **that title to equipment used pursuant to the agreement which is owned by the port or**
15 **a district shall remain with the port or district.**"

16 AMENDMENT NO. 7

17 On page 2, line 13, between "**Section**" and "**shall**" insert "**which is a party to a cooperative**
18 **endeavor agreement described in Subsection B of this Section**"

19 AMENDMENT NO. 8

20 On page 2, line 18, change "**shall**" to "**may**"

21 AMENDMENT NO. 9

22 On page 2, line 21, change "**Subsection C**" to "**Paragraph (C)(2)**"

23 AMENDMENT NO. 10

24 On page 3, after line 2, insert the following:

25 **§326.4. Lafourche Basin Levee District; executive director; assistant executive**
26 **director; duties**
27 **A. The positions of executive director and assistant executive director of the**
28 **board of commissioners of the Lafourche Basin Levee District are hereby**
29 **created. The executive director and assistant executive director shall be**
30 **appointed by the board. The executive director, on behalf of and as authorized**
31 **or directed by the board, shall administer the affairs of the district. The**
32 **assistant executive director shall assist the executive director in all of his**
33 **functions and duties as deemed necessary by the executive director.**

1 **B. The positions of executive director and assistant executive director shall be**
2 **filled by the board within six months after this Section becomes effective if not**
3 **currently filled by administrative rule of the board.**

4 **C. Neither the executive director nor the assistant executive director shall be**
5 **a member of the board. The executive director and assistant executive director**
6 **shall each be a full-time unclassified employee of the board who shall be paid**
7 **compensation in an amount to be determined by the board which shall be**
8 **comparable to like positions with levee districts throughout the state."**
