SPECIAL DAY/WEEK/MONTH: Recognizes Wednesday, May 14, 2014, as Louisiana Orthopaedic Day at the state capitol

A RESOLUTION

2	To commend the Louisiana Orthopaedic Association and to recognize Wednesday, May 14,
3	2014, as Louisiana Orthopaedic Day at the state capitol.
4	WHEREAS, the House of Representatives of the Legislature of Louisiana hereby
5	commends the Louisiana Orthopaedic Association for providing vital medical care and
6	services for the citizens of our state; and
7	WHEREAS, the mission of the Louisiana Orthopaedic Association is to encourage,
8	develop, and increase knowledge and awareness of orthopaedic surgery among the
9	association's present and future members and to foster and assure the highest quality of
10	musculoskeletal health care through all of the following means:
11	(1) Education of orthopaedic surgeons, other health care practioners, and the public.
12	(2) Promotion of research concerning orthopaedic medicine.
13	(3) Effective communication with other health care professionals and the public; and
14	WHEREAS, these and other functions of the Louisiana Orthopaedic Association
15	serve to foster, develop, support, and augment charitable, scientific, and educational efforts;
16	and
17	WHEREAS, the association also monitors legislation, regulations, administrative
18	rulings, and court decisions affecting the practice of orthopaedic surgery, and provides
19	timely reports with respect thereto to the association's board of directors; and
20	WHEREAS, the Louisiana Orthopaedic Association promotes high moral and ethical
21	standards, along with fellowship and good will among its members; and

1	WHEREAS, bone and joint health problems are among the most prevalent and
2	debilitating health challenges that Americans face, both in human and economic terms; and
3	WHEREAS, unencumbered access to orthopaedic care is vital to ensuring that our
4	workers, communities, and economy remain healthy and strong; and
5	WHEREAS, the indirect economic benefit for the annual number of approximately
6	six hundred thousand patients who have a total knee replacement is roughly twelve billion
7	dollars over those patients' lifetimes; and
8	WHEREAS, approximately eighty-five percent of that economic benefit is associated
9	with increased employment and earnings, with the remaining fifteen percent of the benefit
10	associated with fewer missed work days and lower disability payments; and
11	WHEREAS, for an average knee replacement, the total of all medical costs for
12	surgery and rehabilitation is slightly greater than twenty thousand dollars, but these expenses
13	are more than offset by indirect savings of over thirty-nine thousand dollars resulting from
14	that procedure; and
15	WHEREAS, the quality orthopaedic care that the Louisiana Orthopaedic Association
16	promotes is of immense value to this state.
17	THEREFORE, BE IT RESOLVED that the House of Representatives of the
18	Legislature of Louisiana does hereby commend the Louisiana Orthopaedic Association for
19	providing vital medical care and services and does hereby express sincere gratitude to
20	Louisiana's orthopaedic surgeons for their contributions to the health and welfare of the
21	citizens of our state.
22	BE IT FURTHER RESOLVED that the House of Representatives of the Legislature
23	of Louisiana does hereby recognize Wednesday, May 14, 2014, as Louisiana Orthopaedic
24	Day at the state capitol.
25	BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
26	to the president, the executive director, and the legislative chairman of the Louisiana
27	Orthopaedic Association.
