HOUSE BILL NO. 905

BY REPRESENTATIVES ANDERS, HENRY BURNS, AND COX

1 AN ACT

2 To amend and reenact R.S. 38:3087.112 and 3087.114(A), relative to the Black River Lake  
3 Recreation and Water Conservation District; to change the location of the district;  
4 to modify the composition of the governing board of the district; and to provide for  
5 related matters.

6 Notice of intention to introduce this Act has been published  
7 as provided by Article III, Section 13 of the Constitution of  
8 Louisiana.

9 Be it enacted by the Legislature of Louisiana:

10 Section 1. R.S. 38:3087.112 and 3087.114(A) are hereby amended and reenacted to  
11 read as follows:

12 §3087.112. Location

13 The district shall be comprised of all ~~that part of Concordia Parish, to include~~  
14 precincts 4-6, 5-3, 5-4, 5-5, 5-6, and 5-7. ~~and Catahoula parishes bounded by the~~  
15 ~~following description: Begin at the intersection of the centerline of a parish gravel~~  
16 ~~road commonly known as Bodark Lane with LA Hwy 600; thence southeasterly and~~  
17 ~~easterly along the centerline of Bodark Lane to the intersection with the centerline~~  
18 ~~of Deadin Road, a parish gravel road; thence south and southeasterly along Deadin~~  
19 ~~Road to the intersection with the centerline of LA 906; thence southeasterly along~~  
20 ~~the centerline of LA Hwy 906 to the intersection with the centerline of LA 129;~~  
21 ~~thence southerly and westerly along the centerline of LA 129 to the intersection with~~  
22 ~~the centerline of LA Hwy 907; thence northwesterly along the centerline of LA Hwy~~  
23 ~~907 to the intersection with the centerline of LA Hwy 908; thence southwesterly and~~  
24 ~~westerly along the centerline of LA Hwy 908 and the extension thereof to the~~

1 intersection with the Black River mainline levee; thence northerly and westerly along  
2 the centerline of said levee to the intersection with the northwesterly extension of the  
3 centerline of Bodark Road; thence southeasterly to the point of beginning.

5 §3087.114. Board of commissioners, appointment; tenure; vacancies; compensation;  
6 domicile

7 A. The district shall be governed and controlled by a board of ~~six~~ three  
8 commissioners, each of whom shall reside in, or own property in ~~be a qualified~~  
9 ~~elector of the state of Louisiana, owning property within the district.~~ Two members  
10 shall be appointed by the legislative delegation representing ~~governing authority of~~  
11 Concordia Parish, ~~two members~~ and one member shall be appointed by the  
12 governing authority of ~~Catahoula~~ Concordia Parish, ~~and two members shall be~~  
13 ~~appointed by the legislative delegation from the area which comprises the district.~~
