Establishes the Chief Legislative Security Officer and the Legislative Security Council. (gov sig)

Proposed bill creates the chief security officer for the legislature. Provides that the position shall be elected by a favorable vote of a majority of the elected members of both houses of the legislature after being interviewed by the Joint Legislative Security Council and shall be POST certified. This bill provides for the salary of the position to be fixed by the Joint Legislative Security Council. Proposed bill provides for the duties and functions the position including overseeing law enforcement and physical security of state capitol building and state capitol complex, developing an annual budget for the operations of the office, subject approval by the Joint Legislative Security Council and Legislative Budgetary Control Council, employ security officers and other personnel as are necessary to ensure the physical security of capitol building and state capitol complex, ensure that security officers are POST-certified, develop and implement security training, conduct investigations and affect lawful searches, seizures and arrests when necessary. Proposed bill provides for the offices of the legislative security be domiciled in the state capitol building in Baton Rouge. Proposed bill creates the Legislative Security Council and provides that it shall be composed of 10 members of the legislature (5 from House and 5 from Senate). Proposed bill provides for the council to adopt a comprehensive security plan for the parts of the state capitol building/complex that used by the legislature.

EXPENDITURE EXPLANATION

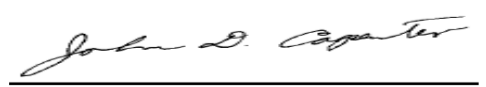
This bill may result in an indeterminable increase in SGF expenditures. According to the bill, one of the major tasks of the council is adopting a comprehensive security plan for the state capitol building and annex. The potential costs associated with the creation of this position and the responsibilities outlined within the legislation will ultimately be determined upon the completion of the council's security plan. The salary of the newly created Chief Legislative Security Officer position will also be determined by the Joint Legislative Security Council. To the extent that internal resources are utilized, any costs associated with this legislation will be minimized.

This bill allows for legislative member per diem and travel reimbursement at the Joint Legislative Security Council meetings. The legislative member per diem rate is \$153 and the mileage reimbursement is \$0.56/mile. The specific expenditures of the council will depend upon the number of meetings held and distance from which the members travel.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
