
SENATE COMMITTEE AMENDMENTS

Amendments proposed by Senate Committee on Transportation, Highways and Public Works to Reengrossed House Bill No. 1252 by Representative Foil

1 AMENDMENT NO. 1

2 On page 1, line 8, after "32:412.1(E)" and before the comma "," insert "and 412.3"

3 AMENDMENT NO. 2

4 On page 1, line 9, after "years;" insert:

5 "to provide for fees; to provide for the distribution of revenue; to create and provide
6 for special funds;"

7 AMENDMENT NO. 3

8 On page 1, line 17, after "32:412.1(E)" delete "is" and insert "and 412.3 are"

9 AMENDMENT NO. 4

10 On page 10, between lines 25 and 26, insert the following:

11 "§412.3. Office of Motor Vehicles Driver's License Escrow Fund; Office of Motor
12 Vehicles Handling Fee Escrow Fund

13 A. There is hereby created, as special funds in the state treasury, the Office
14 of Motor Vehicles Driver's License Escrow Fund, and the Office of Motor Vehicles
15 Handling Fee Escrow Fund.

16 B.(1) After compliance with the requirements of Article VII, Section 9(B)
17 of the Constitution of Louisiana relative to the Bond Security and Redemption Fund,
18 and after a sufficient amount is allocated from that fund to pay all of the obligations
19 secured by the full faith and credit of the state which become due and payable within
20 any fiscal year, the treasurer shall pay an amount equal to one third of the monies
21 received by the state treasury pursuant to the provisions of R.S. 32:412 into the
22 Office of Motor Vehicles Driver's License Escrow Fund. The monies in this fund
23 shall be used solely as provided in Subsection D of this Section. All unexpended and
24 unencumbered monies in this fund at the end of the fiscal year shall remain in the
25 fund to cover under collections in any subsequent fiscal year. The monies in the
26 fund shall be invested by the state treasurer in the same manner as monies in the state
27 general fund and shall be deposited into the state general fund.

28 (2) The calculation required under the provisions of Subsection D of this
29 Section shall be made prior to the distribution to the board of trustees of the police
30 pension funds of the city of New Orleans, the State Police Pension and Retirement
31 Fund, and the Conservation Fund under the provisions of R.S. 56:10(B)(15).

32 C. After compliance with the requirements of Article VII, Section 9(B) of
33 the Constitution of Louisiana relative to the Bond Security and Redemption Fund,
34 and after a sufficient amount is allocated from that fund to pay all of the obligations
35 secured by the full faith and credit of the state which become due and payable within
36 any fiscal year, the treasurer shall pay an amount equal to one third of the monies
37 received by the state treasury pursuant to the provisions of R.S. 32:412.1 into the
38 Office of Motor Vehicles Handling Fee Escrow Fund. The monies in this fund shall
39 be used solely as provided in Subsection E of this Section. All unexpended and
40 unencumbered monies in this fund at the end of the fiscal year shall remain in the
41 fund to cover under collections in any subsequent fiscal year. The monies in the
42 fund shall be invested by the state treasurer in the same manner as monies in the state
43 general fund and shall be deposited into the state general fund.

1 D. Of the monies escrowed in the Office of Motor Vehicles Driver's License
2 Escrow Fund, one-half shall be appropriated in Fiscal Years 2019, 2025, and 2031
3 and one-half shall be appropriated in Fiscal Years 2020, 2026, and 2032.

4 E.(1) Of the monies escrowed in the Office of Motor Vehicles Handling Fee
5 Escrow Fund. In appropriating money from this fund in the fifth and sixth year of
6 the driver's license cycle, one-half shall be appropriated in Fiscal Years 2019, 2025,
7 and 2031 and one-half shall be appropriated in Fiscal Years 2020, 2026, and 2032.

8 (2) Of the monies appropriated under the provisions of this Subsection,
9 sixty-eight and seventy-five one-hundredths per cent of the funds shall be allocated
10 to self-generated revenue and thirty-one and twenty-five one-hundredths per cent of
11 the funds shall be allocated to the Office of Motor Vehicles Customer Service and
12 Technology Fund.
