**CAPITAL OUTLAY**

Provides an exception to the time limit on filing capital outlay requests for filings resulting from a declared disaster where there is an imminent public need for the project. (7/1/14) 2/3 -CA7s11(C)).

Present law authorizes capital outlay budget requests submitted after November 1st to be included in the capital outlay act if the request meets all applicable requirements except for time of submission; and provides 3 exceptions for requests submitted after the November 1st deadline. Proposed legislation retains the present law and adds a 4th exception relative to projects located in designated disaster areas where there is a public need for the project to the November 1st deadline submission of capital outlay requests. Proposed legislation defines "designated disaster area" and "public need" for purposes of an exception to the November 1st deadline for submission of capital outlay requests. It further provides that the project requires the Joint Legislative Committee on Capital Outlay approval which may occur after the February 1st and may have a total project cost of \$1 M or more.
