Purpose of Bill: This measure changes the name of the Wedgewood Civic Association District located in East Baton Rouge Parish to the Wedgewood Crime Prevention and Improvement District. In addition, the measure amends the purpose of the district to include beautification and improvement of the common areas. The measure also removes the requirement for approval of the budget by the East Baton Rouge Metropolitan Council and changes the requirement to submission of the budget to the council.
