7 **at any time prior to the expiration of the three day period. If the two apparent**
8 **low bidders do not submit the proper information or documentation as required**
9 **by the bidding documents within the three day period, such bidders shall be**
10 **declared non-responsive, and from that date, award may be made to the next**
11 **lowest bidder, and afford that bidder not less than three days to submit the**
12 **required information or documentation, and the process may continue until**
13 **either a low bidder is determined or all bids are rejected.**"
