SENATE RESOLUTION NO. 171

BY SENATOR CLAITOR

WATER/WATERWAYS. Requests the Louisiana State Law Institute to create a Water Code Committee.

1 A RESOLUTION

2 To urge and request the Louisiana State Law Institute to create a Water Code Committee.

3 WHEREAS, Senate Concurrent Resolution No. 53 of the 2012 Regular Session of  
4 the Legislature requested the Louisiana State Law Institute to conduct a study on surface  
5 water and groundwater law in Louisiana; and

6 WHEREAS, on April 4, 2014, the Louisiana State Law Institute submitted its report  
7 to the Legislature in response to Senate Concurrent Resolution No. 53; and

8 WHEREAS, such report discusses at length the issues, problems, and questions  
9 arising from the present state of Louisiana law concerning surface water and groundwater,  
10 and concludes by stating:

11 "The time has come for water law reform in Louisiana. It is recommended that a  
12 Louisiana State Law Institute Water Code Committee be created and invested with  
13 the responsibility of continuing to study Louisiana's current treatment of running  
14 surface water and groundwater, with a view towards the development of a  
15 comprehensive Water Code that integrates all of Louisiana's water resources.

16 The Louisiana State Law Institute recommends that the proposed Water Code  
17 Committee be an interdisciplinary committee, composed of academicians,  
18 practitioners, scientists with expertise in hydrology, and government representatives  
19 with expertise in Louisiana's water resources and the state's existing administrative  
20 system of water management.

21 Current Louisiana law provides insufficient guidance on the rules that govern  
22 the nature and scope of riparian and groundwater rights. Louisiana needs a Water  
23 Code that integrates all of its water resources, a Water Code that will enable  
24 Louisiana to successfully manage and conserve its water resources as it prepares to  
25 face the inevitable challenges that lie ahead. Therefore, it is recommended that the

1 legislature implement the foregoing recommendations and that it entrust this  
2 important project to the Louisiana State Law Institute."

4 THEREFORE, BE IT RESOLVED that, in accordance with the above  
5 recommendation, the Senate of the Legislature of Louisiana does hereby urge and request  
6 the Louisiana State Law Institute to create a Water Code Committee in order to develop  
7 proposed legislation establishing a comprehensive Water Code that integrates all of  
8 Louisiana's water resources.

9 BE IT FURTHER RESOLVED that such Water Code Committee shall be an  
10 interdisciplinary committee and shall include academicians, practitioners, landowners,  
11 scientists with expertise in hydrology, and government representatives with expertise in  
12 Louisiana's water resources and the state's existing administrative system of water  
13 management.

14 BE IT FURTHER RESOLVED that such Water Code Committee shall provide  
15 annual reports to the Legislature not later than February first of each year indicating its status  
16 in developing a comprehensive Water Code for Louisiana, and including as appropriate,  
17 specific recommendations in the form of proposed legislation to achieve establishment of  
18 a comprehensive Water Code that integrates all of Louisiana's water resources.

19 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the  
20 director of the Louisiana State Law Institute.
